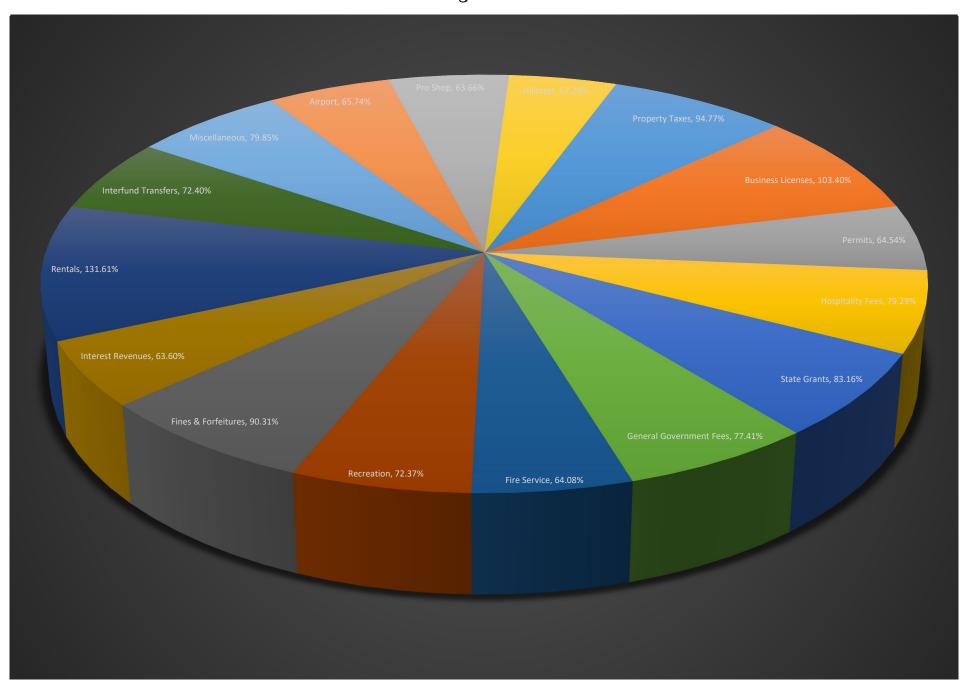

City of Orangeburg Revenue Breakdown Year to Date Figures Fiscal Year 18-19



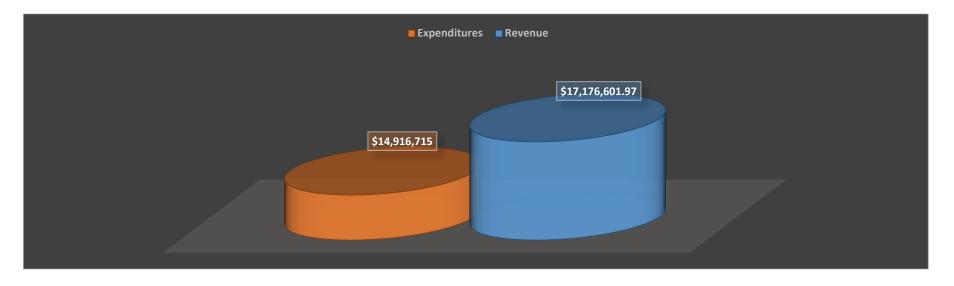

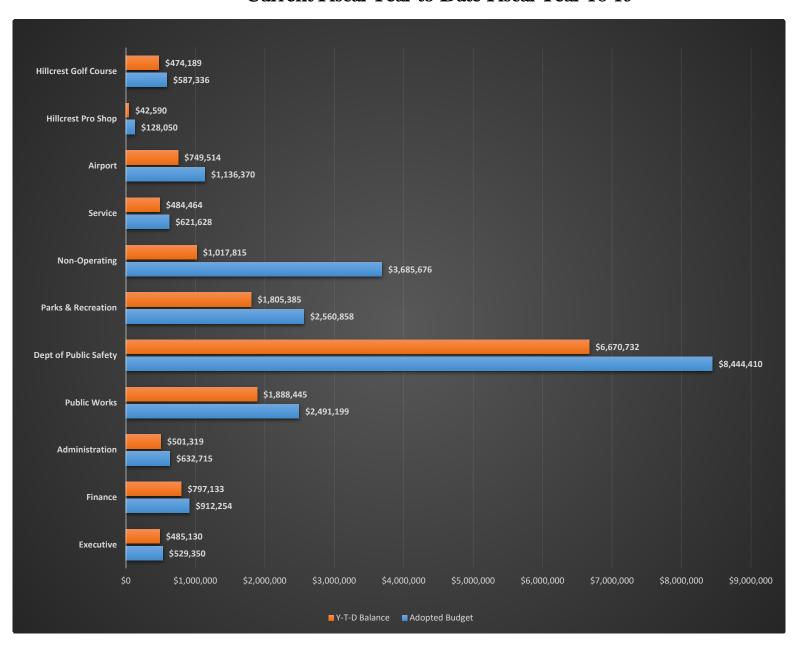
