

**Relief Valves and Expansion Joints**—To be furnished as a part equipment of condensers.

PROPOSALS for barometric condensers will not be considered.

Condensers will be used in connection with uniflow engines and seven feet basement height will be provided for their accommodation. Circulating water and hot water discharge pipe lines will be provided in close proximity to condensers beneath the basement floor.

#### TRIPLEX MOTOR DRIVEN PUMP.

##### PREFACE.

In preparing this List of Requirements, it is not our intention to write specifications, but to place before prospective bidders a list of the equipment together with such special data as we desire incorporated into their standard specifications which will form a part of their proposals.

##### ENGINES.

Bidders are requested to so frame their proposals as to cover the purchase of either one or two engines of the same size and type, and to comply with the following special designations in preparing specifications:

**Rating**—Engines are to have a full load rating of 425 B. H. P. when operating with steam pressure 150 lbs. at the throttle and a vacuum of 26 inches. The lowest water rate should be at approximately 50 per cent. of full load rating.

**Type**—Right hand uniflow, arranged for mounting 250 KW. Alternator and its exciter rotors on shaft.

**Speed**—180 R. P. M. Alternate proposals with a speed of 200 R. P. M. will also be considered.

**Steam Inlet**—Arranged for connection with under floor steam mains, preferably, connecting to bottom or side of cylinder. A "U" bend from under floor to top of cylinder will not be considered.

**Exhaust Outlet**—To be arranged to pass downward through floor to exhaust line connecting with condenser.

**Engine Base and Generator Sole Plate**—To be furnished by engine builder. Generator manufacturer to furnish drawings showing dimensions for engine builders' guidance.

**Economy Guarantees**—Economy guarantees are to be based on actual pounds of steam per brake horsepower. Steam will be supplied from two 264 H. P. longitudinal double drum Babcock and Wilcox boilers through pipe and separators as per drawing, "Steam Lines from Boilers." Guarantees based on dry steam or indicated horsepower will not be considered.

**Delivery**—F. O. B. Orangeburg, S. C., EXCEPT engine shaft, which is to be delivered to generator manufacturer.

#### GENERATORS AND EXCITERS.

Bidders are requested to so frame their proposals as to cover the purchase of either one or two generators and exciters, and to comply with the following special designations when preparing specifications.

**Rating**—250 Kilo-Watt at .80 Power Factor when the maximum rise in temperature after ten hours operation at full load is 40 degrees F. above surrounding atmosphere. (A 5 per cent. variation from 250 K. W. will be satisfactory, if necessary, to procure a generator of manufacturers' standard rating.)

**Voltage**—2,400 volts, when power factor is .80.

**Phase**—Three.

**Alternations**—7,200.

MAXIMUM safe temperature in degrees F. to be stated.

**Mounting**—The generator and exciter are to be mounted on sole plate furnished by engine builder. The rotors are to be mounted on engine shaft, which will be delivered to generator manufacturer by engine builder, and generator manufacturer is to crate and ship engine shaft with rotors mounted with generator.

**Efficiencies**—Efficiency guarantees are to be calculated to include all losses of generator and exciter except friction of engine shaft in bearings.

**Rise in Temperature of Exciter**—To conform to that specified for generator.

**Delivery**—To be F. O. B. Orangeburg, S. C.

**Drawings Showing Dimensions of Generator Sole Plate** are to be furnished engine builder and duplicates are to be furnished to the City of Orangeburg.

#### SWITCH BOARD.

Before going into the details of the switch board, the following statement is made in order that prospective bidders will have a better general idea of the plant size and condition. With this information and the details given below a switch board designer should experience no difficulty in preparing specifications and plans for the complete switch board.

#### Statement.

This switch board is intended for a new plant. The generators, at this time will be the two 250 K. W. units mentioned previously in this list of requirements and one old machine of 125 K. V. A. It is intended that this old unit will be replaced, when the needs of the plant demand it, by a 250 KW. unit similar to the two mentioned. Individual exciters will be used.

There will be two outside feeder circuits, one circuit to the series regulator panel in the basement, for street lighting, and one circuit to furnish motor power for use within the plant.

Proposals are requested for the complete switch board. The following approximate dimensions for the front of complete board are desired: Height, 90 in.; width, 16 ft. 6 in. The following are the panels required in the order named, facing front of board and beginning at the left.

- 1 3-circuit (each circuit 200 KW) EX. panel; or
- 3 20 KW single circuit exciter panels;
- 1 Tirrill Regulator panel;
- 3 300 KW, 2,300 Volt, 3-ph. Gen. panels;
- 2 300 KW do Feeder panels;
- 2 100 KW do Feeder panels.

Remote control non automatic TP DT oil switches for generator panels and feeder panels. All 2,300 Volt oil switches to be mounted on framework to the rear of board. Generator field rheostats are to be located under the floor. All wires, or cables, from switch to generators and from switch to lines will go down from switches. Double three phase busses to be over oil switches.

Each generator panel is to have mounted on it:

- 1 Voltmeter;
- 3 Ammeters;
- 1 Field Ammeter;
- 1 Non-Automatic TP DT oil switch;
- 1 Recording Watt-meter;

Together with voltmeter receptacle, synchronizing receptacle, and field switch.

Each of the feeder panels is to have mounted on it:

- 3 Ammeters;
- 1 TP DT Automatic overload circuit breaker;

The two 100 KW panels are to have in addition, recording watt-meters.

A paralleling switch and synchronizing meter are to be provided for, also.

**Capacity**—When using water of 80 F. degrees temperature must be capable of lifting water from eight feet below base and condensing 7,500 pounds of steam per hour to 26 in. vacuum.

**Drive**—220 volt, 3-phase, 60 cycle motor (or motors) optional proposal—steam turbine.

**Efficiencies**—Power required with both methods of drive when condensing 25 per cent., 50 per cent., 75 per cent., and 100 per cent. of 7,500 pounds.

Communication from Mr. W.W.Watson in reference to his contract for the Street Sweepings was read and referred to Councilman Von Ohsen for adjustment.

Communication from Mrs P.Rich offering to sell a piece of real estate owned by her adjacent to lands now owned by city on which the proposed New Power House is to be erected, was read and received as information.

Yea The Mayor, Councilmen Felder & Von Ohsen.

Mr.J.M.Albergotti appeared before Council with the request that Rowe Street be extended across the right of way of the Atlantic Coast Line Railroad. He stated that he was interested in the development of a large tract of land South of said Railroad, had spent considerable money in this enterprise and the extension of Rowe Street as indicated by him would not only be of advantage to him but would result in the building up and development of that portion of the City.

Motion By Councilman Von Ohsen:- Moved that the matter of the extension of Rowe Street as indicated by Mr.Albergotti be referred to Councilman Felder, City Atty.Glaze and Engineer Hawes, and if in their judgement they deemed said extension advisable that proper resolution be prepared by City Atty Glaze to be submitted to City Council for their action. Adopted.

Yea. Councilman Felder, Von Ohsen and the Mayor.

Rev.Geo.E.Davis representing the Committee in charge of proposed evangelistic Meeting to be held in the City in February under the auspices of some of the religious bodies in the City, requested that City have proposed Tabernacle, which they were building, properly wired and lights installed and current furnished by City, Also that City have same removed when meeting was over and Tabernacle taken down.

Regular Meeting Jan. 14, 1916-- continued.

Upon motion of Councilman Von Ohsen request of Rev. Davis was granted, Supt. Salley instructed to install lights and remove same when necessary, keeping an account of cost entailed and City Clerk and Treasurer to pass check to Water & Light account in payment for same from City funds.

Mr. R. F. Walker, local manager of the Southern Bell Telephone and Telegraph Company, appeared before Council with the request that the Telephone have permission to remove four trees located on the North side of Hampton Street, which interfere with proposed improvement of Telephone system in City.

Report of Engineer Hawes on petition of sundry citizens requesting the piping of open ditch leading from South Broughton Street to Harley Swamp and the filling of pits in vacant lots near Harley Springs, which was referred to him at meeting of Council Oct. 8, 1915, was read. Referred to Councilman Von Ohsen and Engineer Hawes with power to take such action as in their judgement was proper.

By Councilman Von Ohsen:-

RESOLVED. That the Superintendant of Water & Light Plant be authorized to purchase all of the Electric Meters now in use and owned by consumers of electric current residing in the City of Orangeburg S.C. on the following basis:-

Take the cost of new meter of similar size and type and Deduct 5 % of the cost for each year that the meter has been in service, also,

Deduct 3 % of the cost for each 1000 Kilo-Watt-Hours registered on said meter since it has been in service.

The minimum purchase price to be ONE DOLLAR, which is the value that can be secured in trade for another new meter.

BE IT FURTHER RESOLVED. That the City Clerk and Treasurer be authorized to pay for such meters on the above basis when a voucher setting forth the size, type, and cost of the meter at the present time, together with the serial number of same has been approved by the Superintendant of the Water and Light Plant and receipted by the owner of the meter.

Orangeburg S.C.

Gentlemen;

The Petition to City Council, dated October 7 Th. 1915, from citizens requesting the Piping of open ditch leading from South Broughton Street to Harley Swamp, and the filling of Pits in vacant lands near Harley Spring, was placed in the hands of your City Engineer for investigation.

---

First; The ditch referred to is commonly known as the "Steam Laundry Ditch" This ditch was maintained by the city for a number of years, for the past two (2) years nothing has been done by the city in the way of maintenance.

The ditch needs a thorough cleaning out, the logs, bushes and other obstructions removed, If ditch and ditch banks are properly cleaned, and the obstructions removed, so that water will not pond, there is in my judgement no special need from a "Sanitary" standpoint of piping this ditch as long as the effluent from Steam Laundry empties into said ditch, as the said effluent contains Chemicals which are detrimental to the Mosquito, and this waste water is not a menace to health in the community.

If said ditch is piped, it would require a 30" pipe, costing \$2.<sup>:20</sup> per foot for pipe laid and material required to backfill over pipe. The distance from Windsor Street to culvert pipe crossing under Orangeburg Rail Road being approximately 1060 feet, consequently the cost of piping this ditch for this distance would be, including three man-holes on the line \$2400.00

This ditch is wholly upon private property, crossing through lands of various lot owners.

I recommend that if ditch is piped, that the work be built under the supervision of your City Engineer, at the expense of the property owners.

---

Second;

In reference to the Pits in land, in the vicinity of Harley Spring. The Petitioners state that pits were dug by city, To the best of my knowledge and belief the city did not excavate these pits, These pits were dug

by private parties.

I have been on the ground and examined the location of the numerous pits, which are containers of stagnated pools of water. These pits cannot be drained, and should be filled in. Since the City did not excavate these pits, the expense of filling same should be borne by the property owners on who's land the said Pits are located.

---

Further, I would recommend, that the City Council, prepare, adopt and enforce an Ordinance prohibiting the excavation of Pits within the City Limits which cannot be drained. This will eliminate the stagnated pools of water which is lying in such dug out holes, and the city would be free from this menace to health in such communities.

Gentlemen;

As requested at meeting of City Council held on January 14 Th. 1916, I herewith submit costs of improvements on the A.C.L.R.R. Cos. right of way, on the South side of tracks in Rowe Street, and West of Rowe Street to culvert at Mr. J.M. Albergotti's line.

(First) The total cost of a brick culvert 300 feet in length, from the South end of present brick culvert under A.C.L. tracks, to run diagonally through the right of way of A.C.L.R.R. to concrete culvert at J.M. Albergotti's line, also 140 feet of 24" Terra Cotta pipe for a ditch draining turn table pit, The excavation for new culvert, The filling in of present canal, The filling of Rowe Street to grade from the Albergotti line to present track grade will cost \$2280.00

(Second) The cost of 4'2" X 6'7" Brick culvert a distance of 30 Feet in length, built on a curve, to the West side of Rowe Street, the construction of 60 Feet of 24" Terra Cotta Pipe crossing of Rowe street, The filling of present canal in Rowe Street, and the filling of Rowe Street to grade from the A.C.L.tracks to the North line of Rowe Street in land of J.M. Albergotti, will cost \$545.00

Councilman Watson and City Engineer Hawes on prices and submitted samples of street signs as was requested at meeting July 14th.

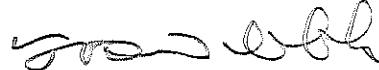

This service is to consist of such water mains as will afford ample fire protection to any houses that may be built in vicinity; the sewer lines shall also be ample for as many houses as may be conveniently built on said property, in the vicinity in which they shall lie, and the electric light line shall also be ample to furnish adequate lights and current for all reasonable service that may be required of same in said vicinity.
