

Verbal application from Mr.J.M.Green for water service on Lyndale Street where he was erecting several tenant houses was discussed . It was decided that the City not being in position at this time to extend the water service from the lack of funds,that this matter be referred to Supt.Salley to investigate and suggest a way water can be supplied as requested,further that if Mr.Green at his own expense and under the supervision of Supt.Salley would install a larger water pipe than the one now in use on that Street that he be given without cost the present one inch pipe now in use.

Councilman Watson was authorized to purchase or arrange for a mule to take place of one now disabled,upon motion of Council man Von Ohser by following vote,

They stated that they had a price on such a wagon suitable for the purpose which would cost \$350.00 which amount they asked that Council would appropriate. Action on this matter was postponed for future meeting of Council.

Councilman Von Ohsen moved tha Supt.J.E.Salley be authorized to have cement and Stone for foundation of Engines to be installed at new Water & Light Station mixed by Mr.J.C.Fairey in his new Mixer at a cost of 50 cents per cubic yard. Motion carried.

Salley on final settlement and it was agreed that estimate made by Engineer Hawes would be final and acceptable to all parties concerned.

IN MEMORIAM.

JOHN B. ETHEREDGE was born in Edgefield County, this State, on April 27, 1867, and died suddenly in this City on Wednesday Jan. 24, 1917.

More than twenty years ago, when he was a young man, he moved to this City and cast his lot with our Citizens. He soon became connected officially with the City Government, having been chosen by the City Council then in office as Superintendent of the Street Department. Through several administrations he held this position continuously until the time of his death. This was a high tribute to his faithfulness and efficiency as an officer, and the high esteem in which he was held by the several City Councils under whom he served. He was well and favorably known by all of our Citizens and the surrounding community. His generous nature and willingness to aid others made him many friends.



Following resolution offered by Councilman Watson and seconded by Councilman Von Ohlsen was passed by unanimous vote of Council,The Mayor,Councilmen Watson and Von Ohlsen each voting "yea".

Moved that Sewer extension on Lyndale Street as per petition of Mr.James M.Green, filed with this body January 26,1917 be allowed under the supervision of City Engineer PROVIDED. That Mr.James M.Green advance the cost of this extension, same to be refunded when the City is in position financially to refund cost. The City not to be called upon for the return of these funds under any circumstances within twelve months. PROVIDED,also, That Mr. Green agree to erect and connect with Sewers laid as provided above nine (9) houses, and that City Attorney be instructed to draw up necessary papers.

An agreement between the City of Orangeburg and the Atlantic Coast Line Railroad Company incident to the laying of Water and sewer pipe under the track of said Railroad Company at Broughton Street Crossing occasioned by the extension of Water and sewer service to Union Avenue, was submitted to Council and following resolution was passed :-

Upon ballot Mr John S.Bowman having received the unanimous vote of Council, three votes, he was declared elected to serve as City Attorney, term of office at will of Council.

A communication conveying the resignation of Mr W.C.Towles from Board of Park Commissioners, read, and resignation accepted. Filling of vacancy was postponed to future meeting.

Regular Meeting March 9, 1917

continued.

City Clerk read communication from Mr. Charlie A. Davis, declining office of Street Overseer to which he had been elected at meeting held February 16th. Letter was received as information by following vote,

Yea The Mayor, Councilmen Watson and Von Ohser.

Council then proceeded to the election of Street Overseer, made vacant by the death of Capt J.B. Etheredge. City Clerk read applications from the following.

A petition from a number of residents and business men of the City, requesting the City Council to insist on better service by the Southern Bell Telephone and Telegraph Company, or if the present unsatisfactory service is not remedied to revoke the license of said Telephone Company and permit the citizens to organize a Local Telephone Company, was read by City Clerk.

Mr. R.P.Walker, local Manager for the Southern Bell Telephone Company was present, Mr. Walker promised immediate improvement of service and requested that Council postpone action on this petition to a future meeting with the understanding that service would be improved.

Action on petition was postponed by unanimous consent, upon motion by Councilman Von Ohser,

Yea The Mayor, Councilmen Watson and Von Ohser.

The Mayor reported to Council the untimely death of Sergeant of Police H.H.Franklin while in the discharge of his duty on March 16, 1917. Sergeant Franklin was fatally shot by one Mackey Palmer whom he was endeavoring to place under arrest, and died at the Baptist Hospital in Columbia from his wounds.

Councilman Watson moves that the construction of the Bridge over Cemetery Branch atk Freedwell Street which was ordered at meeting of Council February 23rd, be let out by contract. Provided, that the cost of said bridge be not over \$260.00

Carried:- Yea The Mayor, Councilmen Watson and Von Ohser.

Supt. J.E.Salley advised Council that owing to the increased cost of Coal at this time that the operating cost of plant is at present more than 50¢ more than six months ago. After discussion Council decided not to increase rates for the present.

MAJOR WILLIAM L.GLAZE.

By the dispensation of an Allwise Providence Maj. William L.Glaze has been called from his earthly labors to his Heavenly reward.

Throughout his long sojourn in our midst he was an active useful and highly respected Citizen.

He was distinguished for his patriotism and public spirit, being ever ready to lend a helping hand in the promotion of all civic enterprises.

In the year 1883 he was elected over distinguished opponents City Attorney of the City of Orangeburg by the Council, and has served in this capacity until his death on the 25th of February 1917, nearly thirty-four years of continuous service.

In the Capacity of City Attorney he gave entire satisfaction to all of our Citizens, being faithful in the discharge of his duties and a wise and safe Counsellor.

This figure contemplates using such pipe and fittings as are available in the old plant and finishing the plant and system complete. This together with the \$1175.00 mentioned above gives

a total \$21,375.00

The \$1175.00 necessary for partial operation, means that the two new engine generator units could be put into service by moving one of the switchboards from the old plant and connecting up with the existing lines of the electric system. This arrangement would remove the necessity of operating any of the old plant except the pumps for fire protection. This would require us to keep steam, with banked fires, and one man on duty at the old plant until the new reservoirs have been completed and the pumps moved.

The electric service would not be materially improved over the present until the complete switchboard with regulators was installed and connected to the system, but the saving in cost of operation would be considerable.

I hope that you will be able to arrange to finance the plant through the coming tight time without recourse to an increase in rate, although I believe it justifiable to raise the rates under the condition existing, it would be opposite to the past policy of the plant, and very much against the wishes of a majority of the people of orangeburg.

Gentlemen:-

In taking up the dicussion of the necessary steps to be taken to offset the 100% increase in cost of coal per ton used in operating the plant, I wish to ask your particular attention to the following facts.

We have the lowest rate for electric current in South Carolina, and our rate for water is but slightly above the average, while the well water that we furnish is far superior in quality to that from rivers, creeks, and ponds furnished by a number of the cities and towns in this state. We have always been very proud of this fact and heretofore have been able to maintain the plant and in addition furnish to the city without a special appropriation for it the lighting of the streets of the city and the public and semipublic buildings of the city as well as water for fire protection, the washing and sprinkling of the streets the public watering troughs, and the flush tanks of the sewerage system. These items would total, at the lowest rates paid by cities of this size not owning their water and light plants, not less than ten thousand dollars a year.

Reference to the past records will show that the receipts of the plant for April, May, June and July of each year rarely exceed the disbursements in any considerable amount but that the earnings of the fall and winter months have been sufficient, heretofore, make up this deficiency. This year, the earnings of the plant since October 1916, while not as much net as in former years on account of the high cost of coal, have been spent in a large measure for extension work in connection with the new plant, so that now we have no reserve to fall back on.

The next three months - April, May, and June - the operating expense disbursements will very probably exceed the income of the plant by \$3000.00. From July to October the new plant will be in partial operation and the operating expense will probably be \$1500.00 less than the receipts. To put it in other words, the six months from April 1st. to October 1st. will cost us \$1500.00 more in operating expense than the receipts for water and electric current for the same period at the present rates.

During the four years prior to Oct. 1. 1916 the average cost of coal delivered at the plant was \$3.68 per ton. For the past three months coal delivered at the plant has cost \$5.39 average, per ton. We have a contract with the Stonaga Coke and Coal Co. @ 2.75 per Ton FOB Mines which with freight of 2.25 and hauling of 30¢ makes the cost delivered, \$5.38 per ton; but we are unable to get shipments on this contract for 1/3 of our needs and have to purchase it wherever we can locate it at prices ranging upwards of \$6.00 per ton.

The City Clerk, Mr. T.O.S. Dibble has for you a financial statement of the plant up to date together with the approximate amount of the outstanding bills, both, payable and receivable, and so I will give you only the estimate of money required to get the plant in operation and to complete it.

Municipal Proclamation.

By virtue of power in me vested by Section 90 of the revised Ordinances of the City of Orangeburg, S. C., (Chap. 8), I do hereby suspend so much of said Section 90, as forbids "the firing or discharging of firecrackers, sky rockets, roman candles and other fireworks in the City of Orangeburg" for the period between 12.05 A.M. Tuesday, December 25th, 1917, and midnight, Tuesday, January 1st, 1918, Sunday excepted, and subject to following restrictions and limitations, to wit:-

1. That on Russell Street, from Doyle to Windsor, the firing or discharging of fire works will only be permitted on above mentioned days between the hours of 7 P.M. and 6 A.M., except that on Christmas Day the restrictions above stated shall be removed.
2. That there shall be no firing or discharging of fire works permitted within the territory included in the limits designated, as follows: beginning at South Church Street, thence along the South side of East Russell Street to Doyle Street, thence South to Calhoun Street, thence west to Middleton Street.
3. That on Tuesday, January 1st, 1918, the firing and discharging of fireworks is restricted to the hours of 6 o'clock P.M. and Midnight.
4. Exploding of dynamite cartridges or bombs of any other design, the explosive power of which is dynamite, is hereby forbidden in any part of the City under severe penalties.
5. All citizens are most earnestly cautioned and warned against the careless shooting of roman candles and sky rockets.
6. All persons are hereby notified to see that their premises are kept clean and clear of all inflammable matter.
7. It is extremely important that every one exercise the greatest degree of care that fires may not occur from the use of fireworks. In the enjoyment of the holiday festivities the danger of fire should constantly be kept in mind.
8. The Police of the City are charged with the strict enforcement of this proclamation and all ordinance governing the use of fire works and firearms within the City of Orangeburg.
