AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED AN ORDINANCE TO PROVIDE FOR THE PUBLIC SAFETY BY REGULATING THE MOVEMENTS OF VEHIOF EVERY KIND ON THE STREETS OF THE CITY OF ORANGEBURG S.C. BY ADDING A SECTION TO BE KNOWN AS SECTION 47-B, PROHIBITING THE USE OF STEEL TIRED MOTOR VEHICLES OR TRAILERS HAULING LOGS, LUMBER, OR COTTON FROM USING CERTAIN STREETS. received third reading and was ordered engrossed, by following vote:-

Yea The Mayor. Councilmen Watson.

Messrs Pelham Felder, D.H. Marchant, W Hampton Dukes and others submitted a petition stating that petition had been filed some time ago for roadway paving of Ellis Avenue and asking that this work be included in the immediate paving now under construction. These gentlemen were assured that Council and Commission had this matter under consideration and were endeavoring to secure funds for this purpose and if successful that roadway on this street would be laid.

Communication from Mr.L.L.Hamilton requestin that arrangements for water and lights for Hamilton Veneer Company be made at once this matter was referred to Councilman Watson and Supt.Pearson. Supt Pearson was to secure prices on necessary pipe and atemporary one inch line to be constructed for which Mr.Hamilton is to pay cost. Mr.Hamilton was present and agreed to this proposition.

Application from the Bludwine Bottling Company for exemption from licenses and taxes as provided by Section 59 of the revised ordinances of the City of Orangeburg, and not claiming exemption for taxes and shigensecs already paid within the five year period was read.

This corporation having complied with requirements of said Sec.59 of the revised Ordinances of City of Orangeburg and having invested over \$5.000 in their plant as required by Ordinance to the satis faction of Council, their petition was granted by following vote:
Yea The Mayor, Councilman Watson.

Communication from Chamber of Commerce Greenville S.C. relative to legislation being enacted at present seesion of General Assembly concerning Hydro-Electric Plants and taxation of individuals was read and City Clerk was instructed to submit same to Young Man's Business League for investigation and reply.

Communication from The Young Men's Business League commending Council on the placing of new Street signs on Street corners and also on Street Paving now being constructed and offering their services if needed to aid in any proposition for the advancement of Crangeburg, was read and City Clerk was instructed to reply to same thanking this progressive organization for sentiments expressed in their communication and also their aid profferred to Council.

City Attorney stated that according to instructions he had secured deed from Mr.E.C.Johnson, for North Development Company, for right of way including all property in City of Orangeburg formerly owned by Orangeburg failway, purchased by them at sale of said road by oredr of the Court and paid the price agreed upon which was \$2.000.00. He had also secured right of way deeds from Messrs W.C.Wolfe, L.L.Hamilton and Enterprise Land Company for which no charge was made.

Above action was approved by City Council as well as the payment of $\frac{1}{2}$.000 from funds of Water and Light Plant by City Treasurer for this purpose by following vote.

Yea The Mayor and Councilman Watson.

City Attorney was instructed to have all these deeds recorded, communicated with the proper authorities of the Atlantic Coast Line Railroad advising them that City wished them to construct proposed side track from their main line to City Power House, along right of way agreed upon and forward deed to right of way for said side track from City to said railroad, by the following vote.

Yea The Mayor, Councilman Watson.

Monutes Regular Meeting January 12, continued.

City Engineer Hawes stated that Mrs E.D.Reeves had called upon him and requested that fence on her property on North Broughton Street which had been taken down when street was straightened some time ago and had not been replaced owing to growing crops on land at that time, be replaced. That the wire was on ground and only new posts would have to be purchased and work could be done by City hands. Council instructed Mr. Hawes to replace fence using the old wire and purchasing new posts using city hands for this purpose.

He also stated that contract for new bridge over the Edisto River had been let and that bridge would cost approximately \$36.516.00 and Cities proportion of cost would be around \$9.000.

In connection with the plant to continue West Russel Street to connect with new Pridge Mr Tawes stated that deed to land over which extension would pass owned by the Bryants had been signed by U.G.Bryant and D.Bryant and that Mr.Robert Lide was to have dower signed by wives of these gentlemen.

Supt Water and Light Plank Pearson stated that Mr W.F.Barton Jr wanted service cut of from his Ginnery at College Avenue and wished to know what would be required of him when again cut In. Mr Barton has one year contract which has not expired.

Council decided that if this service was cut out that when Mr. Barton desires the same cut on he will have to pay back service charge to -date of cut on and instructed Expt. Pearson to notify him of decision.

Meeting then adjourned.

City Clerk submitted letter written Capt.T.E.White relative to piping ditch on their right of way East of Rowe Street and his reply thereto in which he stated that one half of ditch belongs to City and his Company will not pipe ditch on private property. Engineer Hawes was instructed to measure distance of ditch from A.C.L.Track in order to clear up dispute as to line.

City Engineer was authorized to lay 18 inch storm sewer Glover Streetundre old right of way Orangeburg Railway to lands of Hamilton Veneer Company.

He also advised Council that when this money was secured that 1st consideration would be given North Broughton Street from Culvert to City Limits in additional roadway paving , but if petition is not arranged that then additional money would be expended on other streets.

A resolution was passed authorizing the Mayor and City Treasurer to issue note or notes of the City of Orangeburg for the loan of \$50.000 payable two years from date of note at 6 % interest, per annum, the proceeds to be used for the extension of Street work now in progress by following vote:-

Yea The Mayor Councilmen Watson and Sifly.

A committee from Childrens Playground Commission comsisting of Mrs J.M.Albergotti, Mrs Adam Moss and Mr.Rodwell, with Mr. J.M.Albergotti as spokesman. They desired to commence improvements of play ground at Edisto River. The first matter that needed attention is the filling and grading Marleys Dam from Russel Street towards fity Water and Light Plant. The Mayor stated that it was the purpose of City to have Engineer make estimate of this the cost of this work, but on account of the proposed railroad spur track and street work now in progress taking all the time of Engineer it had been impossible to do so. Also, the City was not in position from a financial standpoint to handle the matter at this time. Engineer Hawes stated that he had made no measurements to give an accurate statement of Cost of this work but thought it would cost at least \$\$500.00 for Dam and \$2.500 for playground fill. He said this was simply an off hand estimate and cost may be

more . Mr Albergotti then offerred to advance necessary money to do this work if same was started at once, taking the note of the $^{\text{C}}$ ity payable one year from date at 5 % interest.

Upon motion Mr.Albergotti's offer was accepted and Engineer Hawes instructed to order necessary T C pipe for this work at once. by following Vote:- Yea The Mayor, Councilmen Watson and Sifly.

Dr.C.I.Green was present and in the interest of the paving of Lovel Street and requested Council to use every effort to include this work in present program. His request was referred to Street Improvement Commission.

Invitation from Public Health Association of S.C. to have City represented at meeting of that organization in Charleston on April 17th and 18th by Health Officer read and Council decided to request Dr.Brabham to attend meeting as representative from this City.

Chief of Fire Department, Fischer, called attention of Council to the trouble he is having when responding to alarms with apparatus and also at arrival at fire on account of drivers of Automobiles blocking streets and disregarding traffic ordinance. He asked that a policeman be detailed to accompany apparatus when rolling to fires and be instructed to clear block within which the fire is located of all automobiles in order that department may have room to work.

The Mayor told Chief Fischer that he would instruct the Chief of Police to confer with him and make such necessary arrangements.

Shief Fischer also asked permission to investigate syren street alarm such as is used in Columbia and submit cost at future meeting of Council. Granted.

Petition for roadway paving Treadwell Street from Russel to Ellis Avenue submitted and ordered filed and referred to Improvement Commission.

Ers J.M.Albergotti, iss Annie Hydrick and Dr.V.W. Brabham from the Playground Commission were present to discuss with Council proposed work to be done and fills to be made along river to dam. The Mayor told them that after the Engineer, is awes, had measured up amount of folling required and expense of necessary drainage, that cost would be considerable more than was estimated at last meeting, the work on dam including cost of drain pipe being approximately \$7.500.00, that these figures were much higher than Council expected to have to, pay and that the present state of the finances of City would not permit expenditure of that amount during present year. After descussion of the situation the Committee stated that they would take council with other members of Commission and report back to Council at later date.

Dr.V.W.Brabham, Chairman Board Of Health asked the co-operation of Council towards a "clean up week" that the Board contemplates to put on April 9th to 14th. The Boy Scouts are to be asked to help and the matter of compensation for their services was discussed and matter was referred to Councilman Sifly and Dr.Brabham with power to act.

Dr.Brabham also stated that he desired to enlarge on the inspection of milk, sold within the City, which is now handled by him. The present method covers the cleanliness of the milk but he desired to be permitted to instal in addition to equipment now in use in laboritory ky apparatus for the Bacteriological examination of milk to detect any germs that might be injurious to the public health. Equipment will cost approximately \$185.00 and would to be a valuable addition to work now being accomplished by Department. The Mayor advised Dr.Brabham that Council would take his suggestion under consideration.

ORANGEBURG WATER AND LIGHT PLANT OF THE CITY OF ORANGEBURG

ORANGEBURG, S. C., OCTOBER 1st, 1923.

In Accordance with a Resolution Passed by City Council of the City of Orangeburg, On and After October 1st, 1923, the Following Rules, Regulations and Rates Will Be Effective.

- (1) Bills for water and electric service will be issued monthly, and while the City will make every reasonable effort to see that each patron of the plant receives his bill, no responsibility will be assumed for non delivery when same has been mailed at the Post Office.
- (2) All charges for water and electric current service (1) are due and payable at the office of the Orangeburg Water and Light Plant, during office hours, on the SIXTEENTH day of each month and EXCEPT WHERE SPECIFICALLY STATED TO THE CONTRARY in these regulations and rates. All bills for WATER and ELECTRIC CURRENT paid on or before the FIFTEENTH day of the month in which the bill is dated will be subject to a discount of 10 per cent. Bills will be dated on the first day of the month and will cover service for one month prior to date of bill.
- (3) All services will be metered. Where meters fail to register, bills shall be arrived at by taking an average of the three most recent months.
- (4) The consumer making payment by mail is entitled to discount only when Post Office canceled stamp evidences mailing on or before the FIFTEENTH day of the month in which payment is due.
- (5) All bills that have not been paid on the last day of the month in which bill is dated, will have added a FIFTY CENT collection charge and will be turned over to a collector who will present the bill at the place where water and electric service is being furnished for payment. If this bill together with the collection charge is not paid service will be discontinued.
- (6) When service has been discontinued for non payment as in paragraph (5) charges for all service to date become due immediately and service will not be re-installed until all bills due, together with collection charges, and cut in charge of FIFTY CENTS per service has been paid and a forfeit deposit, similar in amount to the amount paid in settlement, made with the City.
- (7) A forfeit deposit equal to two months probable service will be required from all users of Water and Electric Current in the City of Orangeburg, S. C.
- (8) No claim or demand that the consumer may have against the City shall be considered as an offset against the payment for service furnished under these regulations.
- (9) These Rules, Regulations and Rates are intended to apply only to water and electric service furnished within the City limits of the City of Orangeburg, S. C., but may be applied in whole or in part to service furnished without the City limits provided that in no case shall the charges for service furnish without the City limits be less than the rates specified. Increased rates may be applied to services without the City limits where conditions warrant and special contract is entered into.
- (10) No additional service will be installed until a contract, clearly stating rates, discounts, charges, etc., has been entered into. The same to be a state of the same plant through a south of the contract the same

- These Rules, Regulations and Rates are referred to in, and made a part of, each contract for water and electric service.

WATER.

- 3. That unless your petitioner can acquire the strip of land above mentioned ant thus bring his lot out to the right-of-way of said railroad he will suffer great inconvenience in his proposed business arrangements, as well as financial loss and disapointment.
- 4. That it is the purpose of your petitioner to establish a business on the location mentiomed above that will bring revenue to the City by way of taxes, as well as attracting other industrial establishments to same locality which would in effect develop that part of the City which is now undeveloped.

Wherefore your petitioner prays that your Honorable body convey to him, by usual form of deed, the strip of land mentioned above as lying between his lot and the right- of - way of said railroad, at a resonable price.
