A novel suggestion of Mr. Wolfe was was that the present courthouse be remodelled along lines which he suggested, including the stuccoing of the exterior wall, which could be done very cheaply. In fact, according to one of the leading architects of the state, he whole building could be fixed up, said Mr. Wolfe for a sum between \$13.000 and \$20,000.
Mr. Wolfe presented the petition of those urging that the building be retained, and stated that the right of petition was a sacred matter. He secured some applause from the ladies present by denouncing the contemplated removal of the building san act of vandalism, declaring that no private citizen would remove the building if he happened to be the owner of it. The petitions presented by Mr. Wolfe contained a total of 774 names and was said, by him, to represent three-fourths of the taxable property of the city. Both Mr. Wolfe and Col. Salley suggested that the council hold an election on the question. This was also advocated by Mr. M. K. Jeffords and others. Mr. F. F. Malpass, Mr. W. W. Watson and Mr. D. H. Marchant also made short statements affirming their position, in support of the petitions handed in.

This report, er was unable to see who the speaker was but after the meeting our information is that he apolo-gized for his remark. In concluding his talk Mr. Al-bergotti presented to the council a series of petitions, containing the names of 1.701 persons who requested that the council proceed with its original intentions and de-molish the court house and im-prove the site as a public park. When Mr. Albergotti concluded he was followed by Mr. Mt E. Zei-gler, Esq. who closed the argu-ment for those wishing the court house removed. Mr. Zeigler said he would be the last to request council to violate an agreement, whether moral or legal, but took the position that the council was trustee for the public sentiment. The council made no announce-ment of its decision at the meet-ing, Mayor Jennings remarking that the matter would be tak

Minutes of an Executive Session of the City Council held on April 27th, 1928.

In reaching and announcing our decision, in the matter of tearing down or retaining the old courthouse, it is advisable to review the whole matter, leading up to its present status, as set forth as follows:

To begin with, the City Council realized that the strong agitation for the removal of this as a Court House site was for various reasons, the foremost of which were its location, making the noise most objectionable for court purposes, which condition was becoming more pronounced, and the size of the lot, making the erection of the new building thereon almost out of the question.

It was also, at that time, a conceded fact that this old building, in addition to being out of date and regarded by many as an eyesore that had outgrown its time, was occupying the most prominent spot in the city, a site that has for prominence and possibilities few equals in the state.

With these factors, and many others, to consider the agitation began in a general way for the City to buy the property, remove the old building and develop the site into a beautiful square, commensurate in every way with the city:s growth, to be used for the benefit of one hundred per cent of the people who come into our growing little city and, necessarily, become a great asset of unusual beauty.

Then, to justify the above, or rather to get the sentiment of the people, it was talked on the streets, written of in the papers, discussed in the various clubs and every method used to advertise this. No opposition that we knew of could be found.

Believing that we were doing a service for the City that would become more pronounced as the time passed, it was then that the city council had a conference with the Orangeburg Court House Commission while in session and after a full discussion it was agreed by the two bodies (as set forth in written communications thereafter) that the city would furnish any site decided on by the commission, plus an amount to equal an upset price them agreed on for the old Court House site, with explicit understanding (which was understood by every member of both bodies and specifically written in our original proposal and confirmed in the deed) that the old building would be removed and the square developed along the lines finally worked out for the benefit of all who come into our City.

The City then had the delegation to pass a special bill in the Legislature empowering the City to borrow an amount not exceeding \$75,000.00 to pay for the project, after which the money was secured and transfer of title made.

It was then that the City, under the supervision of a Government expert (which expert strongly recommended taking down the old building after being asked as to the advisability of both plans) worked out plans for the development of the square, which plans have since been on display at the office of the Secretary of the Young Men's Business League for the people's inspection.

A short while after this there arose opposition by some of the citizens to taking down the building and this finally crystallized by petition being circulated by both sides of this matter and presented to the City Council. On April 19th, a special hearing was granted, by request, to review the merits of the case at which meeting petitions were filed by both sides of the controversy and discussions and resolutions heard from anyone who accepted the opportunity.

It now becomes the duty of the City Council to make a decision in the matter, which we are now doing and giving our reasons for the same.

In the first place, we have tried to consider every angle of the situation and, while we believe it not as weighty as some other reasons, it might be well to say that we find that to renovate the old building, the interior and repainting the outside, would cost an amount equal to that proposed to carry out our original plans and still leave the old building otherwise looking exactly as it now does.

It was also found that to rebuild both interior and hull in

the exterior with suitable trimming would cost a large amount and the same could be better used to build a better building elsewhere as was found out by the Court House Commission. This was not favorable as the City Council does not propose any new expenditures of money except to take care of gradual developments as arise from time to time.

In reviewing the petitions we find that about twenty four hundred white citizens have expressed themselves and over two to one have asked that the original plans be carried out. It seems, furthermore, that the City is, as stated above, both morally and legally bound to carry out its agreement and, consequently, we are finding ourselves embarrassed in being asked, even by a minority, not to do so.

We, therefore, cannot see but that it is our duty to proceed with the original plans according to our agreement, which we have decided to do.

We want to say that this matter has caused quite a degree of concern to us, in noting the feeling developed, and, while we recognize the utility factor, as considered by the various clubs for meeting places, we see no reason why the same request for a meeting place could not be made of the City at any time for such a building and it may be that the City, after the river development is completed, can see its way clear to building such a building without raising taxes which must not be done.



Under the terms of the original lease of the Municipal Theatre, the said building was leased for a term of one (1) year with a privilege to renew the said lease for a period of five (5) years.

The lease provided that the first year should run from the day when the said theatre was turned over to the lessees. The theatre was delivered to the lessees prior to December 19th, 1927, because on that day the first show was presented to the public. Therefore, the first year under the lease expired on December 18, 1928, or an earlier date, and in order to exercise the privilege of a five-year renewal, it was necessary that official and legal notice be given the City of such exercise on or before December 18th, 1928.

Inasmuch as there has been no exercise of this option by the assignees of the original lessees, the terms of the original lease are no longer binding upon either the City or the lessees and the latter have no right or benefit whatever under the original lease, having declined to exercise the renewal option which the lease provided.

Therefore, in the interest of the citizens and taxpayers of the City of Orangeburg, new bids should be called for for the rental of the said theatre, open to all, in order that the City may secure as large a return from the rental of the said theatre as is possible.

The undersigned, as it notified the Council several months ago by letter, is prepared to lease the said Municipal theatre and will appreciate being duly notified of the new call for bids which will be necessary now that the original lease has expired.

The Reliance Theatre, also, makes a formal bid to rent the Municipal theatre upon the same or similar terms of the old lease which expired on December 18, 1928, and to pay the City an annual rental of Twenty Seven Hundred (\$2700.00) Dollars, or Two Hundred Twenty-five (\$225.00) Dollars each month, for the said theatre.

If the above offer is rejected, the Reliance Theatre will submit a bid when the City calls for the same, as is now necessary since the old lease has expired.

I have examined the lease of the City of Orangeburg to Carolinian Theatre, Inc., the said Carolinian Theatre, Inc., having succeeded to all of the rights and privileges of the lessee in the lease of the City of Orangeburg to Orangeburg Theatre, Inc., dated May 25th, 1927, by proper assignment, with the written consent of the City of Orangeburg. The lease referred to grants the Theatre to the lessee therein named for the purposes therein stated "for the full term of one year, commencing on the date that the said Theatre is completed as planned by the said City and turned over to the lessee therein", and further provides that at the expiration of the said year the lessee shall have the option to extend the lease for a period of five years, subject to certain terms and conditions therein setforth.

I find from the records in the office of the City Clerk, that the Theatre was turned over to the lessee therein named on December 19th, 1927.
