

As citizens and Tax Payers of the City of Orangeburg the stockholders of the Reliance-Bluebird Corporation wish to enter an emphatic protest against the partial attitude of the city in its policy concerning the new theater. At this time we will not go over past history and repeat the various occasions upon which the City government kas gone out of its way to favor whoever happened to be managing this theater but we wish to direct your attention to a specific situation which you are allowing to continue, which is absolutely unfair to our legitimete business interests and entirely improper as a method of using public property.

We have inquired from City Clerk T.O.S.Dibble as to the payment of rent for the use of this public property and he informend us Wednesday that rent now owing and past due from March 1st ,which means that there is more than \$1.400.000f rent unpaid, The effect of this is to give a business which is in competition to ours an indirect subsidy from city treasury, and we do not see how it can appeal to your conception of fairness or the proper care of city's interest.

The do not know if this letter will have any weight with you or not. At a previous time when rent had been uncollected for alittthe more than three months we discussed this matter verbally with two members of the Council and both agreed with us that it was unfair for the city to furnish a business competing with other citizens a theater without requiring that the agreed rent be paid.

We present this's matter to you, asking for no favors for our thea ters but earnestly requesting that the city discontinue its policy of favoritism and discrimination in order to help keep as competing business open. We feel certain that if this involved a business in which you were interested you would readily see the injustice of the City's furnishing such a business with an excellent place of business and allowing it to be used without beguiring the rent to be paid.

We feel satisfied that the great majority of the people would be shocked to know that there is over \$1.400.00 rent in arrears for this municipal theater and we believe that they would agree also with us that it is unjust favortism to a business in competition with that of other citizens. We would appreciate very
