

Council agreed to appropriate \$1200.00 per year. if so much be needed by the following vote, Yea, the Mayor, Councilmen Walker and Wannamaker.

Request from the Orangeburg County Fair Association for an appropriation of \$150.00 to entertain the visiting student bodies was granted by the following vote, Yea, the Mayor, Councilmen Walker and Wannamaker.

A resolution authorizing the Mayor to sign an agreement with the Atlantic Coast Line Railroad Company whereby the railroad gives and grants unto the City of Orangeburg the right to lay and maintain pipes under the tracks was granted by the following vote, Yea, the Mayor, Councilmen Walker and Wannamaker.
