CLAIMING INCOME TAX WITHHOLDING EXEMPTIONS FOR DEPENDENTS ON FORM W-4

Notice to Employer:

Before the Revenue Act of 1951 was enacted, an employee could not claim an income tax withholding exemption for a dependent whose gross income for the year was \$500 or more. The Revenue Act of 1951 increased this limit to \$600. Therefore, a person whose gross income is less than \$600 per year and who meets the other requirements as an employee's dependent may be claimed as a dependent on the employee's withholding exemption certificate, Form W-4. It will be appreciated if this change in law is brought to the attention of employees, some of whom may be entitled to claim additional withholding exemptions.

It will NOT be necessary for an employee to file a new Form W-4 if he is not affected by this change in law, and his exemptions are otherwise correctly claimed. However, an employee who is entitled to increased exemptions because of this change in law, should file a new Form W-4 if he wishes to claim additional exemption.

Form W-4 has been revised as of November 1951 in accordance with the change in law. Two copies are attached, and additional copies may be requested from this office. Employers and employees may continue to use the old Form W-4 (Revised October 1948), however, bearing in mind the increase from \$500 to \$600 in the income limitation for dependents.

BRAILSFORD, Mayor, ARTHUR C. WALKER and HAROLD H. WANNAMAKER, constituting the entire City Council; Mr. Brailsford, Mayor, presiding, and Mr. L. F. Theiling, Clerk, recording.





AN ORDINANCE

PROVIDING FOR THE ISSUANCE OF ONE HUNDRED FIFTY-SEVEN THOUSAND (\$157,000.00) DOLLARS CONSOLIDATED REFUNDING BONDS OF THE CITY OF ORANGEBURG, SOUTH CAROLINA, AND TO PROVIDE FOR THE PAYMENT THEREOF.

WHEREAS, heretofore, on or about the 12th day of December, 1919, the City Council of the City of Orangeburg did direct the issuance of the following bonds of the City of Orangeburg, to wit:

- \$100,000.00 5% Bonds for the purpose of paying for permanent improvements on the streets of said City, said bonds being designated as STREET IMPROVEMENT BONDS;
- 45,000.00 5% Bonds for the purpose of extending and enlarging the Waterworks of said City, said bonds being designated as WATER BONDS;
- 45,000.00 5% Bonds for the purpose of extending the Electric Light Plant of said City, said bonds being designated as ELECTRIC LIGHT BONDS;
- 10,000.00 5% Bonds for the purpose of extending the Sewerage System of said City, said bonds being designated as SEWERAGE BONDS;

all of said bonds being dated January 1st, 1920, maturing January 1st, 1960, with the privilege of redemption by the City on and after January 1st, 1940; and,

WHEREAS, subsequent thereto, to wit, in the year 1920, the said bonds were duly sold; and,

Section 1.

That the statements made in the recitals hereof as a preamble hereto, after due and careful investigation, are ascertained and found to be in all respects true and correct.

Section 2.





10,000.00 5% Bonds for the purpose of extending the Sewerage System of said City, said bonds being designated as SEWERAGE BONDS;

all of said bonds being dated January 1st, 1920, maturing January 1st, 1960, with the privilege of redemption by the City on and after January 1st, 1940; and,

WHEREAS, subsequent thereto, to wit, in the year 1920, the said bonds were duly sold; and,

WHEREAS, each of the bonds of the aforesaid issues did contain a provision giving to the City of Orangeburg the right to call and redeem the same on and after January 1st, 1940; and,

Section 1.

That the statements made in the recitals hereof as a preamble hereto, after due and careful investigation, are ascertained and found to be in all respects true and correct.

Section 2.

It is further found and determined that each and every bond of the following issues of bonds of the City of Orangeburg, to wit:

Said bonds shall mature in numerical order in annual series or instalments as follows:

\$15,000.00 on December 1st, in each of the years 1954 to 1955, inclusive; and

\$12,000.00 on December 1st, 1956;

both principal and interest of said bonds shall be payable in legal tender money of the United States of America at the principal office of the Chase National Bank, in the City of New York, New York.

Section 4.

The bonds shall be signed by the Mayor, attested by the Clerk and Treasurer of said City, under the Corporate Seal of the City of Orangeburg, but the interest coupons attached to said bonds need not be authenticated otherwise than by the facsimile signatures of said Mayor and said Clerk and Treasurer who are in office on the date the bonds bear. The delivery of the bonds so executed shall be valid notwithstanding any changes in office occurring after such execution; PROVIDED, HOWEVER, in the event of vacancy due to the death, resignation or otherwise of any of the said officers who may have been in office on the date the said bonds bear, the execution of said bonds by the officers in such office at the time of such execution shall be a valid execution of said bonds and the said bonds shall be valid notwithstanding such changes.

Section 5.

The said bonds shall be exempted from all State, County, School or Municipal taxes.

Section 6.

Minutes of the Regular Meeting of the City Council held
December 8, 1939 and minutes of a Special Meeting held
December 9, 1939 read and approved.

Mr. Thomas B. Bryant and Dr. J. Elwood Welsh appeared before City Council in behalf of the First Baptist Church, which is now engaged in rebuilding the church which was damaged by fire in the spring.

They reported that the exterior wall of the church building was ready for completion and that a question had arisen over the type of construction involved. The brick wall, according to the architect's plans, stopped five (5) feet below the eaves and the wall was thereafter completed with wood construction. This, they said, was not according to the terms of the city ordinance and this had been called to their attention by the fire chief, the building inspector for the City of Orangeburg. Mr. Bryant explained that it would cost about Seven Hundred (\$700.00) Dollars additional to continue the wall with brick, and the City Council was requested to permit the church to complete the wall with wood.

Chief Fischer, as building inspector, reported to the Council that the contemplated construction did not conform to the City Ordinance, that it would increase the fire hazard and endanger the church in the event that adjacent buildings caught fire. He said that he had discussed this matter with the church committee and the architect, advising them that, in his opinion, the church would suffer serious damages in the event of a fire.

Mr. Bryant and Dr. Welsh explained to the Council that they appeared before them in response to a suggestion from the fire chief who advised them that unless the City Council took cognizance of the matter he would be compelled to enforce the terms of the ordinance.

The City Clerk reported that no objections had been filed with him to the opening of a funeral home at 137 West Russell street by Robert Bethea and William Moorer, and the same was granted by the following vote,
Yea, the Mayor, Councilmen Walker and Wannamaker.

An application from Paul R. Weber to open and operate a lunch counter and soda fountain at 214 East Russell street was granted by the following vote,
Yea, the Mayor, Councilmen Walker and Wannamaker.

The City Engineer, Mr. Hawes, reported to Council that the culvert on Green street near the Betsill property was in a dangerous condition and he stated that the cost of installing a new culvert would be \$670.00, of which the W. P. A. would furnish \$299.00. The City Engineer was instructed to proceed with the work at once by the following vote,
Yea, the Mayor, Councilmen Walker and Wannamaker.

An ordinance providing for the public safety on the streets in the City of Orangeburg passed second reading as amended by the following vote,
Yea, the Mayor, Councilmen Walker and Wannamaker.

A resolution authorizing, His Honor, the Mayor, and L. F. Theiling, City Clerk, to pay \$1250.00 on a note covering Street Improvement in the City of Orangeburg and to renew the balance of said note for \$10,000.00 at the First National Bank until July 1, 1940 with interest at the rate of four (4%) percent per annum was passed by the following vote, Yea, the Mayor, Councilmen Walker and Wannamaker. R E S O L U T I O N


WHEREAS, the City of Orangeburg has completed certain improvements on streets in the Moss Heights area and on Union Avenue, and

NOW, BE IT RESOLVED by the Mayor and Councilmen of the City of Orangeburg, in council assembled and by authority of the same:

THAT his Honor, James M. Brailsford, Mayor of the City of Orangeburg, be and he is hereby empowered to borrow the sum of Ten ^vThousand (\$10,000.00) Dollars from the First National Bank of Orangeburg, S. C., and that the Mayor and L. F. Theiling, the City Clerk and Treasurer are hereby authorized to execute a note in the sum of Ten Thousand (\$10,000.00) Dollars, dated January 1, 1940, and payable to the First National Bank on July 1, 1940, with interest at the rate of four (4%) per cent. per annum; the said City of Orangeburg hereby pledges the abutting assessment accounts outstanding against the property owners for the improvements hereinabove referred to as security for the payment of the said note and pledges the full faith and credit of the City of Orangeburg to the payment of the said note.
