Theiling, the City Clerk and Treasurer are hereby authorized to execute a note in the sum of Seven Thousand Seven Hundred (\$7,700.00) Dollars dated January 1 1941 and Payable July 1 1941 to the First National Bank of Orangeburg S.C. with interest at the rate of (4%) four per cent per annum. The City of Orangeburg hereby pledges the abutting assessment accounts outstanding against the property owners for the improvements herein above referred to as security for the payment of the said note and pledges the full faith and credit of the City of Orangeburg to the payment of the said note.


