WHEREAS: The President of the United States, by Executive Order signed on May 20, 1941, created the Office of Civilian Defense, and

WHEREAS: The Office of Civilian Defense has requested the cooperation and assistance of the State of South Carolina in carrying out the Civilian Defense program, and

WHEREAS: The law creating the South Carolina Council of Defense was passed by the General Assembly of the State of South Carolina and signed on May 7, 1941, and

WHEREAS: It is desirable to coordinate municipal defense activities in one municipal agency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ORANGEBURG, S.C.

- Section 1: There is hereby created the Civilian Defense Committee of the City of Orangeburg to be composed of the Mayor as Exofficio Chairman and five members, to be appointed by the Mayor. The Mayor shall designate one of the members appointed as Vice Chairman, who shall be the Coordinator for the City of Orangeburg. Each of the other members shall be chairman of a division set up under the South Carolina Defense plan----George I. Whetsell, vice chairman; O. S. Burns, Planning Division; W.T.C. Bates, Necessities Division; John F. Pearson, Utilities Division; Paul Agnew, Communications Division.
- Section 2: The Civilian Defense Committee of the City of Orangeburg shall be charged with the duty of coordinating all defense activities of this city. It shall:

(1) Coordinate the activities of city and private agencies cooperating in the defense program;

(2) Direct information regarding the defense program to all City Departments or agencies which are, or may be, affected thereby;

(3) Conduct Studies, Survey existing facilities and preferred facilities and make recommendations to insure that City of Orangeburg will, at all times, be abreast of the problems of defense;

(4) Act as a clearing house on City defense information and perform such other advisory functions as may be requested by the State Council of Defense or the National Government Departments in connection with the defense program;

(5) Keep in contact with the State Council of Defense so that there shall be a free exchange of information and suggestions between the two bodies;

- Section 3: The Civilian Committee of the City of Orangeburg may expedite procedure by the organization of divisions and sections, by subdividing its work and by prescribing such rules and regulations as are not in conflict with the provisions of this Ordinance. Any person appointed to any position created under this Ordinance may be removed by the appointing authority for any reason deemed by it to be sufficient.
- Section 4: This Ordinance is hereby declared to be an emergency measure and shall cease to be in effect when the emergency shall have ceased to exist. It shall take effect immediately on execution and publication in the official journal.
