In not voting as Mayor Walker and Councilman Wannamaker did in the election of Mr. Stacy Fairey as City/Collector I would like to make this statement: $74 \times$

The City Tax Collector gets a monthly salary and in addition a fee for the collection of past-due taxes. This fee is added to the tax at the time of collection. Also the City Clerk gets a part of these past-due fees besides his regular salary.

I am against this fee system. If we are going to have a tax-collector he should be paid a monthly salary with no fees going to him or to # the City Clerk, but all fees should be paid into the City Treasury. However I think the tax-collectors office a needless one due to the fact that most of our property taxes are collected when due. The compound tax could be collected the same way if due notice is given. Even if we did have to have a tax collector I believe we would save money over a period of time if we used one of our special officers for this job.

For the job I suggested to Council that we assign Sgt. George Dukes and that he be given a leave of absence from his regular duties on the Police Department.

The collection of taxes would last only a few months and after that period is over it would be very foolish to have this added expense of a year-round salaried collector.

This statement is made for what I feel is the the best interests of the taxpayers of the City of Orangeburg.

RESOLUTION

WHEREAS, there have occurred in the City of Orangeburg within recent months numerous cases of typhus, an endemic disease, and

WHEREAS, the Board of Health has made special investigation into the causes of this condition, having consulted officials of the State Board of Health and the U. S. Health Service, and, after due and careful investigation of various places, is satisfied that the spread of this disease is due to the large number of rats which now infest certain areas and places within the said City, and

WHEREAS, it is necessary, for the preservation of the public health, to eliminate certain nuisances detrimental to the public health which now constitute sources of foulness and causes of sickness hazardous to the public health,

NOW, BE IT RESOLVED by the Board of Health of the City of Orangeburg, That the Board of Health hereby proclaims and declares the following nuisances detrimental and hazardous to the public health:

(1) All buildings and structures of any kind, now ratinfested or in such condition as to attract or harbor rats; and

(2) The accumulating or dumping of all decaying or injurious vegetables, garbage or other substances upon which rats may feed, upon any public or private place unless contained in metal containers, with metal covers, or other rat-proof containers.

BE IT FURTHER RESOLVED by the said Board of Health that the Health Officer of the said City, his subordinates and workmen are hereby authorized, instructed and ordered to:

(1) Enter and inspect all premises, including private and public places, suspected of tontaining nuisances, sources of foulness or causes of sickness hazardous to the public health, or other conditions detrimental to the public health;

(2) Immediately notify the owners, or where owners cannot be promptly served with notice, the tenant, or tenants, of all public or private places, of nuisances discovered by such inspection and in said notice, issued by authority of this Board, require the said owners, or tenants, to immediately abate and remove the said --2--

nuisances;

(3) Upon failure of the said owners, or tenants, to obey the written order of this Board for the abatement or removal of said nuisances, to enter upon said premises, whether public or private, and remove and/or abate the said nuisance, keeping an accurate account of the cost and expenses necessary.

(4) To mark all public or private places or structures, which, for any reason, are or continue to be infected or constituge a nuisance detrimental to the public health or a cause of sickness hazardous to the public health.

BE IT FURTHER RESOLVED by the Board of Health that the City Council of the City of Orangeburg be served with a copy of this Resolution and requested to immediately enact an Ord nance requiring that all business houses, boarding-houses, restaurants, hotels, rooming-houses, commercial stables and all public or private structures in which chickens, dogs, horses, mules, cows or other animals are kept, be rat-free and rat-proof; that all food and feed kept for feeding such animals be kept and stored in rat-free and rat-proof containers, and that all citizens be required to dump all garbage, decaying or injurious vegetables, or other similar substances, in metal containers with metal covers or other containers that are ratproof; and that it be made a misdemeanor for any person, whether owner or tenant, to create or allow any condition to exist on premises owned or occupied, which attract or are likely to attract, feed or harbor rats.

BE IT FURTHER RESOLVED by the Board of Health that the violation of the terms of the ordinance hereinabove outlined is hereby declared to constitute a nuisance, hazardous to the public health, and a source of foulness or cause of sickness, hazardous to the public health.

That such record shows, in my opinion, that all requirements of law pertaining to the legal and proper acceptance of said Offer, including requirements as to the calling, convening and holding of the required meeting or meetings of the City Council, the place of such meeting, the number of members of the City Council present, the submission of and the voting upon the various propositions at such meeting or meetings, legal notices, publications, and all other matters affecting the acceptance of such Offer, have been properly and legally fulfilled and otherwise carried out.

4. That in my opinion said Offer of the United States of America has been legally and properly accepted by said Owner, and there is now in full force and effect a binding agreement resulting from such acceptance between the United States of America and said Owner effective as of the 10th day of March, 1942.

WHEREAS, there has been filed with the Federal Works Agency for and in behalf of City of Orangeburg, Orangeburg, South Carolina, (herein called the "Owner"), an application for Federal assistance under the Defense Public Works program, and the United States of America, acting by and through the Federal Works Administrator, has transmitted to the Owner an Offer of Federal Assistance in connection with the public works referred to in said application and described in said Offer; and

WHEREAS, said Offer has been duly read in open meeting and has been fully considered in every respect in accordance with the pertinent rules of procedure and legal requirements; and

WHEREAS, said Offer has been made a part of the public records of the Owner; and

WHEREAS, it is deemed advisable and in the public interest that said Offer be accepted:

Minutes of Regular Meeting held February 13 and of Regular Meeting held February 27, and of Special Meetings held March 4th, 9th and 10th were read and approved.

An opinion filed with the City Clerk, by Hugo S. Sims, City Attorney, recommending that the plans of the Defense Plant Corporation in connection with the proposed agreement between the City of Orangeburg and the Hawthorne School of Aeronautics not be accepted, was read and Council adopted the recommendation of the City Attorney by the following vote, Yea, the Mayor, Councilmen Wannamaker and Doar. (See Resolution attached to and made a part of these minutes)

The City Council passed a Resolution agreeing to modify its agreement with the Hawthorne School of Aeronautics so that the said school canvepnvey the thirty (30) acres of land to the Defense Plant Corporation by an ungualified fee simple title and assigned its lease covering the 501 acre track to the said Defense Plant Corporation, subject only to the provisions that the said lease shall terminate if the said land is not used for a period of twelve (12) months as a flying school by and for the United States Government by the following vote, Yea, the Mayor, Councilmen Wannamaker and Doar (See Resolution attached to and made a part of these minutes)

" AN ORDINANCE TO REGULATE LICENSES IN THE CITY OF ORANGEBURG FOR THE FISCAL YEAR BEGINNING APRIL 1, 1942 AND ENDING MARCH 31, 1943" passed second reading as amended by the following vote.

Yea, the Mayor, Councilmen Wannamaker and Doar.

The Mayor and City Clerk were authorized to sign a Resolutions for the Home Fire Insurance Company, \$30.45; Calvert Fire Insurance Company, \$73.70; Service Fire Insurance Company, \$123.90 and The General Exchange Insurance Company, \$134.90 - the said amounts being in full settlement of the 2 % fire insurance license fee for the year ending December 31, 1942, by the following vote, Yea, the Mayor, Councilmen Wannamaker and Doar.

A Resolution from the trustees of the South Carolina Firemen's Association authorizing the City Clerk, as trustee, to sell five bonds (\$1000 each) now owned by the City of Orangeburg Firemen's Fund was read by the Clerk. This amount along with an additional \$2,000 to be leaned to the City of Orangeburg for the purchase of a fire truck.

A Resolution authorizing the Mayor and City Clerk to execute a note in the sum of \$8,803.00 and payable to the trustees of the Firemen's Fund of the City of Orangeburg, with interest at the rate of 2 %, per annum, and the provision that at least \$500.00 per year be paid on the principal was passed by the following vote,

Yea, the Mayor, Councilmen Wannamaker and Doar. (See Resolution attached to and made a part of these minutes)

The report of the Chief of Police for the month of February: Number of Arrests 38 Fines & Forfeitures \$182.00 Days on Public Works 160 Transferred to Magistrate 2 Financial report of the City Treasurer for the month of February received as information.

A request from the Orange Cotton Mills that they be allowed to operate seven (7) days in the week due to certain government contracts, was passed by the following vote, Yea, the Mayor, Councilmen Wannamaker and Doar.

In connection with proposed agreements between the City of Orangeburg and the Hawthorne School of Aeronautics, the City Attorney feels that it is his duty to make the following observations:

Under the agreement dated July 24th, 1941, the City of Orangeburg, assisted by the County, has spent a little more than \$63,000.00.

Some \$8,000.00 of this amount has been recovered by the sale of assets on lands purchased, so that the cash investment amounts to \$55,000.00, not including work performed by the County of Orangeburg or the City for which no charges have been made.

The Hawthorne School of Aeronautics has an investment, at this time, as we are advised, of \$215,000.00. Thus, it appears that the City has approximately a one-fifth investment in the property that is now being used by the Hawthorne School.

Under the agreement of July 24, 1942, the City attempted to secure some protection for its investment by including a provision that if the site was not used for the training of pilots for a period of sixty days, the City could, at its option, cancel the lease of the said land.

In addition, under the same agreement, which gave the Hawthorne School of Aeronautics the right to remove its improvements at the termination of the agreement, the City was given the right of purchasing such improvements, in whole or in part, at a price not to exceed the amount which the Hawthorne School of Aeronautics may be able to realize by removing the said improvements.

These are valuable rights now in the possession of the City of Orangeburg and represent, to a large degree, the sole justification for the City's expenditures in connection with the location of the said school.

It should be pointed out that on September 26, 1941, the City, in order to facilitate a loan of \$190,000 to the Hawthorne School of Aeronautics by the R.F.C., agreed that in the event of a default by the said school, any purchaser should have a period of six months to commence operations required by lease. In addition, the City agreed that the School should have a fee simple title to a certain thirty-acre tract of land upon which buildings and improvements were to be located.

The City was recently advised by the Hawthorne School of Aeronautics that it contemplates transferring its interests in the said site, both in regard to the thirty acres and the five hundred and one acres leased, to the Defense Plant Corporation, to which the City consented. The City of Orangeburg is now asked to waive practically its entire rights in and to the said land.

After consultation with officials of the Hawthorne School, the Mayor and the City Attorney conferred with J. Wendell Coombs, of the Defense Plant Corporation, in Washington, D. C. By letter, dated March 9, 1942, Mr. Coombs writes the Mayor as to the requirements of the Defense Plant Corporation and this record should contain the statement Chat his letter does not Conform to agreements reached with him in Washington. Moreover, in the opinion of the City Attorney, the letter is absolutely worthless as to any promise made, or implied, to the City of Orangeburg.

It can readily be appreciated that the Defense Plant Corporation would require, perhaps, an unrestricted fee simple title to the thirty acres of land covered by the agreement but it was distinctly agreed by Mr. Coombs, in the presence of the Mayor, that the City of Orangeburg would be given the first option to purchase the said lands and its buildings if and when the Defense Plant Corporation decided to sell the same.

The agreement submitted to the City Council in regard to the five hundred and one and fourttenths acres of land covers a period of ten years at a rental of One Dollar per year and gives to the Hawthorne Schoel, or to any purchaser from it, absolute and unconditional control of the said five hundred and one and four-tenths acres.

No provision whatever is made for the cancellation of this

lease if it is not used as a flying school for a period of twelve months, and, in fact, under the present agreement, the Hawthorne School of Aeronautics, or anyone claiming under its lease, could use the land for any purpose it sees fit or not use it at all, and the City would be entirely helpless in the matter.

In this connection, for the record, it should be stated that Mr. Coombs, in the presence of the Mayor, Mr. Howard, and Mr. Greenough agreed that the lease should be in connection with an air school, training school or airport, operated by the Government, a governmental agency, or some instrumentality in connection with the Government or for the Government. Moreover, he agreed that it should be cancelled if not used as a flying school for a period of twelve consecutive months.

The supposed agreement as to the Jennings Municipal Airport places the City upon very delicate grounds for the simple reason that the City constructed the said airport under the regulations of the C.A.A. and an ordinance now on the books of the City covers its operations and places definite responsibilities upon the ^City. In accordance with this ordinance, the City has leased the said Jennings Municipal Airport for operation as a public airport, the said lessee at this time being J. E. Horne.

In connection with the Jennings Airport, it was thoroughly understood by Mr. Coombs, at our conference, that the City would have the right to cancel the said lease upon four months' notice if use of the said airport interferred with the City's opportunity to acquire a more modern airport through the program of the Civil Aeronautics Authority. In his letter of March 9th, Mr. Coombs refers to "civil pilot training operations," which, so far as the undersigned knows, was not discussed at any time.

It should be born in mind, in connection with the proposed agreement, that the City has no direct contractual relation with the Defense Plant Corporation and receives no consideration whatever for executing the proposed agreements, dated March 13, 1942. The presumption is that these agreements will lead to expansion of

operations by the Hawthorne School and this is presumably correct, but there is nothing in any agreement to require either expansion or operation, or nothing to protect the City in the event that the training program is abandoned in the next year or so.

Under the agreements proposed, the City transfers all its rights to the Hawthorne School of Aeronautics for a period of ten years for a rental of One Dollar per year. After ten years, the City can only expect to receive the 501.4 acres of land for which it has paid approximately \$20,000. By reason of the fact that it will not be suitable for agricultural purposes at that time, the land will be of much less value. It should be noted in this comnection that an allowance of some \$7,000.00 has been made for approximately 260 acres of land east of the railroad, which was purchased from the Felder Estate.

The attention of the City Council is further directed to the fact that upon the signing of the present agreements with the Hawthorne School of Aeronautics, the City of Orangeburg will divest itself of its rights, regardless of whether the interests of the said School are subsequently transferred to the Defense Plant Corporation, or to some one else.

This statement is made as a legal fact without any intention of casting any aspersion upon the good faith of the Hawthorne School of Aeronautics. In fact, it is a distinct pleasure to state that this School, in its dealings with the City, both in the person of its President, Mr. Howard, and its attorney, Mr. Greenough, has displayed to the highest degree, complete good faith. They have been open-handed, above-board and entirely fair in all discussions relating to the rights of the City of Orangeburg, and the writer is glad to express his confidence in their integrity.

In conclusion, the City Attorney wishes to state that it is not his premise to advise the City Council as to matters of policy, or to question its good judgment in regard to any transactions related to the affairs of the City. Nevertheless, he feels that it is his duty to call attention to the doubtful legality of

giving away, without any consideration, valuable property rights which now vest in the said City and for which the City has expended a relatively large amount, which even now remains to be paid for by bond issue, or otherwise.

Mr. Coombs' statement that it is not the policy of the Defense Plant Corporation to refund local municipalities for any funds which they expend incident to inducing the flying schools to locate at or near their locality, does not apply to the present situation. The City of Orangeburg is not asking the Corporation to refund the money expended.

In fact, the City of Orangeburg has willingly and gladly agreed to the transfer of the entire plant to the Defense Plant Corporation for its use as a flying field in connection with National Defense without regard to the amount invested. The Corporation, as a matter of policy, is demanding more than the Hawthorne School of Aeronautics required or the defense program's needs and is doing so without regard to the rights of this municipality. It demands the surrender of all rights without being willing to give the City any protection whatsoever.

For the reasons above stated, I hereby advise the City Council that, as City Attorney, I cannot approve the legality or the form of the proposed agreements, or, if they are signed, can I assume any remonsibility in connection with protecting the rights of the City in accordance with the agreement dated July 24, 1941, by and between the City of Orangeburg and the Hawthorne School of Aeronautics.

WHEREAS, the Hawthorne School of Aeronautics, now operating a flying school in connection with National Defense, has requested the City of Orangeburg to modify the terms of its agreement with the City of Orangeburg in order that the said Hawthorne School of Aeronautics may convey to the Defense Plant Corporation an unqualified fee simple title to a certain tract of land, containing thirty acres and, at the same time, assign to the said Defense Plant Corporation its lease on a certain other and adjoining tract of land containing five hundred and one acres; and

WHEREAS, the Mayor of the City of Orangeburg, accompanied by the City Attorney, conferred with the Defense Plant Corporation in Washington, D. C., through J. Wendell Coombs, an official of the said Corporation, and, whereas, at such conference, it was agreed by and between the representatives of the City of Orangeburg and the said J. Wendell Coombs, representing the Defense Plant Corporation, that if the City of Orangeburg modified its contractual agreements with the Hawthorne School of Aeronautics so that the said School could convey the said thirty acres of land to the said Corporation, that the said Defense Plant Corporation, in consideration of the modification of the agreement between the City of Orangeburg and the Hawthorne School of Aeronautics, would agree to a clause in the lease of the five hundred and one acres, providing for the termination of the said lease if the said land was not used for a period of twelve months as a flying school operated by or for the Government; and

WHEREAS, the said Defense Plant Corporation, through its said J. Wendell Coombs, agreed for and in consideration of the modification of the agreement between the City of Orangeburg and the Hawthorne School of Aeronautics, that upon acquiring an unqualified fee simple title to the thirty acres of land, it would agree to give the City of Orangeburg the first option to purchase the buildings on the said tract of land at a price not exceeding the best offer feceived by the said Defense Plant Corporation for the said tracs of thirty acres and the buildings thereon,

NOW, BE IT RESOLVED by the Mayor and Councilmen of the City of Orangeburg, in council assembled and by authority of the same:

That the said City Council hereby agrees to modify its agreement with the Hawthorne School of Aeronautics so that the said School can convey the said thirty acres of land to the Defense Plant Corporation by an unqualified fee simple title and assign its lease covering the five-hundred-and-one-acre tract to the said Defense Plant Corporation, subject only to the provision that the said lease shall terminate if the said land is not used for a period of twelve months as a flying school operated by or for the Government.

BE IT FURTHER RESOLVED that the City of Orangeburg, upon redeiving a contractual agreement, executed by the proper officials of the Defense Flant Corporation, properly probated, agreeing to the conditions hereinabove outlined in consideration of the modification by the City of Orangeburg of its agreements with the Hawthorne School of Aeronautics, is prepared to execute the attached or similar agreements, dated the 13th day of March, 1942, subject to the modifications herein contained; provided, that the agreement of the Defense Flant Corporation specifically binds itself to give the City of Orangeburg the first option to purchase the buildings on the said thirty acre tract of land at a price not exceeding the best offer received by the said Corporation when it elects to sell the said thirty acre tract of land and the buildings thereon.

BE IT FURTHERRESOLVED that the conditions outlined in a letter to the Hon. A. C. Walker, Mayor of the City of Orangeburg, and signed by the said J. Wendell Coombs for the Defense Plant Corporation, be and the same are hereby declared unacceptable to the City of Orangeburg and not in accordance with requirements hereinabove outlined in behalf of the City of Orangeburg.

RESOLUTION

WHEREAS, on September 23, 1938, the Sunnyside Cemetery Company, Inc., of Orangeburg, S. C. dissolved its charter of incorporation and transferred its title and interest in all property held by said corporation to the City of Orangeburg, and,

WHEREAS, the City of Orangeburg accepted transfer of said property and assumed full responsibility for the operation and maintenance of the same,

NOW, BE IT RESOLVED by the Mayor and Councilmen of the City of Orangeburg, in council assembled and by authority of the same that the name of the property, "Sunnyside Cemetery," shall remain unchanged and that the City of Orangeburg will seek to operate the said cemetery not for profit, but that reasonable charges shall be made for lots purchased, for maintenance of lots and other services rendered, in order that the property shall be self-sustaining as far as possible; and that the City Clerk and Treasurer shall act as Secretary and Treasurer for the purpose of making and recording all collections and disbursements relative to all business transactions involved in the conduct and operation of the said cemetery.

The following Rules and Regulations shall be observed:

SOUTHEAST SECTION:

The following rules and restrictions governing the operation of the cemetery are devised and adopted in the interest of the maintenance and improvement of the cemetery property as a whole:

1. Lots purchased shall be subject to all provisions and regulations as herewith set forth and those that may be adopted in the future.

2. Lots shall be used only for the purpose of interment of the human dead of the Caucasian race.

3. No interment or disinterment will be allowed on any lot without written permission of the lot owner, or his or her nearest of kin, and also the consent of the cemetery officials.

4. All sales or transfers of lots shall be made through the office of the Secretary and Treasurer. Likewise, all charges for interment, disinterment and lot care shall be payable in advance at said office of Secretary and Treasurer.

5. A service charge of Three (\$3.00) Dollars per year, payable in advance on April 1st of each year, will be made for the annual upkeep of each lot of 400 square feet. Half lots of 200 square feet will be serviced upon the payment of a service charge of Two (\$2.00) Dollars per year, in advance. 6. Perpetual care may be purchased on any standard-sized lot of 400 sq. ft. upon the payment of the sum of One Hundred (\$100.00) Dollars. This amount will be held in trust and the interest accruing therefrom will be used annually for upkeep of the lot. Perpetual care on other than standard-sized lots will be based in proportion, depending on size. The cost for perpetual care of halfsized lots will be Sixty (\$60.00) Dollars.

7. No lot shall be filled above the established grade, nor shall grave mounds be allowed.

8. Use of rough field stones and brick or wooden edging for outlining lots or graves will not be permitted.

9. No cradles, copings, fences or other enclosures will be permitted.

10. All monumental work shall be constructed of no other material than cut stone or real bronze. Artificial makeshifts and unsightly objects will not be allowed. Special permission for the erection of mausaleums shall be secured only after submitting plans and specifications and contemplated location of the proposed structure to cemetery officials.

11. Foundations for all monumental work shall been of a firstclass standard concrete mixture and all foundations for either markers or monuments shall be installed only by the duly employed caretakers of Sunnyside Cemetery. Certain fixed charges, based on the sizes of the monumental work to be erected, will be made for the installation of all foundations. These charges shall be payable in advance to the Secretary and Treasurer unless satisfactory credit rating is established. Specifications of monumental work to be installed shall be submitted at least ten (10) days in advance of actual installation in order that ample time may be had for pouring of necessary foundations.

12. Every foundation must be at least as wide and as long as the base stone that will rest upon it, and must not project above the surface of the ground. Also, every foundation must extend as low as the bottom of the grave, or in such manner as shall be prescribed by the custodian of the cemetery property.

13. Monumental dealers will be required to comply with City License regulations before undertaking any work on the cemetery property.

14. The proper priming of any trees and shrubs or the removal of any diseased or dead plant shall be done at the discretion of the demetery officials.

15. It shall be within the right and authority of governing officials of the cemetery to alter any walks or drives and make such disposition of the same as they deem proper in promoting the general welfare of the cemetery.

NORTHWEST SECTION:

The Northwest section, as yet only partly developed, has been planned for sale of lots under perpetual care only. In this section, there will be over one hundred (100) lots available. The entire section will be developed as a lawn area, with ample, yet a minimum, number of drives and will be attractively landscaped. All regulations heretofore set forth shall likewise govern this area, and, in addition thereto, the following rules and restrictions will apply to this area only:

1. All lots will be marked at each corner with a suitable



marker which will be set on a level with the existing grade of the lawn; and in no case will copings, fences or other enclosures be permitted.

2. Only one (1) monument will be permitted on each lot and this must be placed in the center of the lot.

3. Grave markers shall be of cut stone of the following dimensions: 2 ft. $x \mid ft. x \in in$. with $l\frac{1}{2}$ drop bevel top and shall be set not over 6 inches above ground level.

4. Where single grave space is purchased, no monument will be allowed, but a marker, as specified in paragraph No. 3 above, will be permissible.

5. No trees, shrubs or other plants shall be planted on any lot in this section without the approval of the cemetery officials.

The prices of lots shall range from \$50.00 to \$100 in Southeast Section, without perpetual care.

The prices of lots in the Northwest Section, with perpetual care, shall range from \$100.00 to \$150.00.

Single grave space, \$20.00; Infant grave space, \$10.00.

Interment charges, \$5.00; infant interment, \$2.50.

Further information in regard to Sunnyside Cemetery may be had by consulting the custodian on duty at the Cemetery.

Minutes of Regular Meeting of Council held November 27, 1942, read and approved.

Financial report of the Chief of Police for the month of November: Number of Arrests 97

Financial report of City Treasurer received as information.

A communication from Mr. F. B. Birthwright, of the Southern Railway System, also from Mr. N. D. Womble, Agent, Atlantic Coast Line Railway Company, advising Council that the matter of blocking crossings will be investigated and remedied, at once, were read and received as information.

The City Clerk read a petition signed by property owners in the vicinity of 18 Orange Court, opposing the granting of a permit to Mr. R. S. Mellette to keep a cow on his premises, and Council refused to grant the permit by the following vote, Yea, the Mayor, Councilmen Wannamaker and Doar.

The City Clerk advised Council that after checking the tax books for the number of free holders, a petition requesting the election for the issuing of \$210,000 General Obligation Bonds to retire outstanding notes finds a majority of the free holderholders have signed, and this matter was referred to the City Attorney.

Mr. R. G. Carson, representing the Public Welfare Department, of Orangeburg county, and Mrs. J. L.
