



Gentlemen:

I beg to hand you, herewith, report of delinquent tax collector and License Inspector for year ending February 28th, 1943.

During the past year I have made periodical inspections of all places of business in the City of Orangeburg and I find that they all have business licenses as required by the ordinance.

Since June 1st, 1942, I have collected \$756.00 delinquent street taxes and it is expected that before April 1st, 1943, when the new street taxes become due, additional street taxes for 1942 will be collected.

On February 1, 1942, I took office as Delinquent Tax Collector for the City of Orangeburg and at that time the amount of outstanding taxes for the years 1933 to 1941 amounted to \$9727.14. On January 1, 1943, the 1942 taxes became delinquent and this amounted to \$3912.76, making a total of \$13,639.90 of delinquent taxes that was turned over to me for collection. To date I have collected and paid into the City Treasurer \$6136.00, leaving outstanding taxes for the past ten years of \$7503.90 which I still hold for collection.

Upon careful investigation of the delinquent taxes, I find that of the \$7503.90 taxes outstanding there is \$1005.51 uncollectible, and I would recommend at this time that the above amount be charged off. I wish to call your attention to the fact that \$795.80 of the above amount represents charge offs for the years 1939, 1940, 1941 of which no amount has been charged off to date. These taxes represent parties that have moved away from the city, bankrupts, nulla bonas, double entries etc.

A schedule of the above amount has been filed with the City Clerk and Treasurer for your examination. After deducting the above amount the total amount of outstanding taxes for the past 10 years would amount to \$6498.39.

With the assistance of the Delinquent Property Tax Investigator and the County Auditor of Orangeburg County, I have added to the City Tax books additional taxes in the amount of \$1,391.98 as follows: year 1941 \$665.57 and 1942 \$726.41. These taxes represent tax payers who either failed to make tax returns or were late in making the same. Of the above amount approximately 75% has been collected to date.

Walker, Mayor of the City of Orangeburg, be and he is hereby authorized to renew a note in the sum of Fifteen Thousand (\$15,000.00) Dollars from the Southern National Bank, the said amount being borrowed under an Act of the General Assembly, approved by the Governor on May 3rd, 1938, authorizing the City to borrow Twenty Five Thousand (\$25,000.00) Dollars to pay for certain improvements in and around the Tri-County Hospital; that the Mayor and the City Clerk & Treasurer are authorized to execute a note in the amount of Fifteen Thousand (\$15,000.00) Dollars dated Dec 1, 1943, and payable to the Southern National Bank on June 1, 1944, bearing interest at the rate of four (4%) per cent, per annum; the full faith and credit of the City of Orangeburg is hereby pledged to the payment of the said note according to the terms of the said Act, which provides that not less than Two Thousand Five Hundred (\$2,500.00) Dollars be paid on the principal of the said note each year and the City of Orangeburg hereby pledges itself to pay the sum of Two Thousand Five Hundred (\$2,500.00) Dollars on the principal of the said note on June 1, 1944.
