Dear Mr. Brown:

The writer wishes to express to you his appreciation for the kindnesses extended him on yesterday.

In line with our conversation, we wish to state that we have ample personnel of the proper experience and professional abilities to handle the Sewage Treatment Plant for the City of Orangeburg, and could upon your request furnish you with recommendations.

We would be glad to file an application with the Federal Works Administration, Bureau of Community Facilities, for Advance Planning Funds on this project, which application would include necessary investigations, reports and preliminary sketches and plans, at no expense to the City.
