

In the sameer of 1941, the City of Orangeburg, in order to essist in the Sational Defense Progres, acquired certain real estate and made certain improvements in connection with the location of the Newtherne School of Aeronautics near the City of Orangeburg.

On July 25, 1941, the Grangeburg County Delagation, by appropriate legislative authorization, contributed the sum of \$15,000 to the development of the said airport in connection with the National Defense Program, and the County Pressurer paid the said sum to the City of Opangeburg.

It was provided that the City of Orangeburg agree "that in the event this property shall over be sold or its use discontinued as an airport, then and in that event, the proceeds from such disposal sale of the said property shall be divided between the City of Orangeburg and the County of Orangeburg in the propertion that the two units of government have contributed to the purchase and development of the said property."

Whe Hastherne airport property, as you are probably assis, has been declared surplus by the Ner Assets Administration. It was recently put up for sale and the City of Orangeburg is about to acquire title to the part of the real estate con eyed to the Mational Government, together with certain improvements thereon, for the sum of \$30,000.

The records of the City reveal that the City of Grangeburg has invested \$36,608.32 in the said property and the County of Grangeburg has sade a contribution of \$16,000.

This means that out of the total of [51,608.32, the County of Grangeburg contributed twenty-nine per cent. and the City of Grangeburg seventy-one per cent. Accordingly, the County of Grangeburg, if it wishes to have any further interest in and to the property used as the airport, should aske a contribution of twenty-nine per cent. on the purchase price of [30,000. This ascents to [8,700.00.

The City of Opengeburg, therefore, offers to the County of Opengeburg the ppportunity to provide the sum of \$8,700, which will be its provets share of the \$30,000 for which the Mar Assets Administration is ready to release all its right, title and interast in and to the said property.

Without this payment it will be impossible to use or dispose of the property heretofore devoted to the uses and purposes of the Governsent of the United States and the Hawthorne School of Aeronautics.

As Mayor of the City of Grangeburg and acting for the said City, I call this matter to your attention in order that the County of Orangeburg may take such stops as it desires in connection with protecting its rights under the agreement of Joly 26, 1941, Of course, the additional \$30,000 still make a total investment of \$81,608 in the property. Whether there exists any possibility of recepturing anything like this sum to a disposal of the property, if such disposal should prove feasible, is uncertain. However, thedity of Orangeburg feels that this is the appropriate time to have a clear-cut understanding with the County of Orangeburg as to any claim that it may wish to protect in connection with the said agreement.

I will appreciate very such being advised of the decision of the belogation as early as possible and in the event that the County of Orangeburg decides to put up its pro rate share, it will be appreciated if you will have the County Treasurer send the City of Orangeburg a check for \$8,700.00 immediately.

Your letter of June 16th, 1947, addressed to Messrs. T. B. Bryant, James M. Brailsford, Jr., Hugo S. Sims, Jr., Marshall B. Williams and Charlton B. Horger, Senator and Representatives from Orangeburg County, was taken up by them at a recent meeting of the Delegation, at which time they decided that the matters referred to by you should properly come before the Orangeburg County Highway Commission and requested that I present your letter to the Commission for action. Your letter was presented at the Commissions' regular meeting yesterday.

The Commission appreciated the offer of the City to permit the County to participate with the City in the repurchase of the thirty acres previously sold to the Hawthorne School of Aeronautics but does not feel that a repurchase of this property would be a proper step for Crangeburg County and it, therefore, declines the offer.

The Highway Commission is thoroughly in accord with the suggestion of the City wherein you state: "However, the City of Orangeburg feels that this is the appropriate time to have a clear-cut understanding with the County of Orangeburg as to any claim that it may wish to protect in connection with the said agreement."

The Commission feels that there should be an accounting between the City and the County relative to receipts from the original sale of the thirty acres of land to Hawthorne School of Aeronautics, the sale of timber and investments by the County for improvements, which are in addition to the \$15,000.00 referred to in your letter, and also such other items as may properly enter into a computation of the respective rights and interests of the City and County in and to the real estate involved.

The Highway Commission authorized Mr. L. C. Boone, County Engineer, in conjunction with any person or group whom the City may designate for the purpose, to state the accounts subject to the approval of the City and the Highway Commission. It is suggested that the plan adopted by the Commission is probably the easiest manner in which this situation can be clarified, and if it meets with the approval of the City, you can so notify me or Mr. Boone, and I am sure that he will be prepared to proceed promptly in cooperation with the City's representative. (3) That the owner or tenant, or other person putting up the One Hundred (\$100.00) Dollars deposit or carrying the insurance provision herein above referred to shall, at the time of making the said deposit or of notifying the City Clerk and Treasurer about the fire insurance policy provision shall sign the following release:

\_, the owner or tenant of Ϊ., property located outside the City of Orangeburg hereby requests the Orangeburg Fire Department to render such assistance as may be possible at the time in the event of a fire effecting my said. property; the sold assistance to be rendered if the said fire Department is in a position to do so and if it can do so without undue risk to property within the City of Orangeburg; in the event that the Orangebur Fire Department is unable to answer any author-ised call to fight fire affecting my property, I hereby release the City of Orangeburg from any and all liability in connection with any loss sustained, it bein the essence of this agreement that the City of Grangeburg assumes no obligation whatsoever and is to receive no pay ent unless the Orangeburg Fire Department responds to a call from me; in the event that I make a call upon the Fire Department, and the Fire Department sends any men or equipment to the address given below, then and in that event, regardless of the services rendered or not rendered by the said Department, I agree to pay the City of Orangeburg the sum of One-Hundred (1100.00) Dollars; this amount having been deposited with the City Clerk and Treasurer for the purpose of guarantee-ing such payment and when it has been applied in payment of any services rendered, than and in the event this arrangement immed-iately ceases; I request the City of Orangeburg to make possible this assistance without any assumption of risk, obligation or guarantee on the part of the seid City in regard to any fire that may occur or threaten my property. I also agree that the said deposit, or any funds available under my insurance policy, shall apply in payment of the sum of One Hundred (\$100.00) Pollars per call for any call made by me for the purpose of protecting my property, or the property of any other person. I hereby authorize the Fire Department to respond to any call for assistance that is made by eithor of the following persons:
