
Pursuant to provisions of Section 47-1004, as amended, of the Code of Laws of South Carolina, Notice is hereby given that City Council of the City of Orangeburg will hold a public hearing at 6 P. M. on Friday, January 6, 1956 in the Council Chambers at City Hall, in the matter of amending the Zoning Ordinance of the City of Orangeburg by changing the District Classification from "A-2 Residence District" to "B-1 Retail Business District" for the following area:


"Beginning at the present Eastern boundary of the B-1 District on the 800 block of Russell SE and extending easterly a distance of approximately 120 feet at a depth of approximately 225 feet to include properties now numbered 870 and 880 Russell SE."


Such hearing to be for the purpose of hearing all comments, or receiving statements, for or against the proposed amendment changing the Zoning classification of the area above described.





WHEREAS, The City Council is advised that the Water Pollution Control Authority of the South Carolina State Board of Health has under consideration the classification of the Edisto Rivers and tributaries and

WHEREAS, the City of Orangeburg is vitally interested in such classification because of its municipally operated bathing beaches, water supply system and sewage treatment plant, all of which will be directly affected by the classifications applied to the North Edisto river, and

WHEREAS, the public recreational facilities of the City of Orangeburg on the North Edisto river require an "A" classification, which classification would also satisfy the water system intake requirements; and the sewage treatment plant effluent discharge (downstream of the recreational areas and raw water intake) requires a "C" classification, which classification would also serve existing valued industries, which contribute materially to the economic life of the City,

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Orangeburg, in council assembled and by authority of same hereby requests that the Water Pollution Control Authority of the South Carolina State Board of Health establish the following classifications of the North Edisto river:

Class "A" from a point 1000 feet North of the Atlantic Coast Line Railway bridge and extending upstream for a sufficient distance to insure the maintenance of "A" classification for that portion of the river adjacent to the City.


Class "C" for that portion of the river extending from the point 1000 feet North of the Atlantic Coast Line Railway bridge downstream to the confluence of the North and South forks of the river.

WHEREAS, It is necessary that the approval of the South Carolina Public Service Authority be had in order to obtain the extended area service; NOW, THEREFORE,



NOW, THEREFORE, Be it resolved that the Municipality of Orangenburg does hereby consent to the construction or improvements of the aforesaid municipal street, or streets, in accordance with the aforesaid plans, thereby evidencing compliance by the State Highway Department with the provisions of Section 33-172, Code of Laws of South Carolina, 1952; and further, the Municipality, having reviewed the plans for said construction, does hereby approve said plans, as heretofore identified, as provided for in Section 33-173, of the 1952 Code, it being understood that by such approval, the Municipality hereby assumes all liability which the State Highway Department might otherwise have as a result of damage to property or persons resulting from such improvement, construction, reconstruction, or alteration carried out in accordance with the plans herein approved.

BE IT FURTHER RESOLVED, That the Municipality will legally protect the right of way as shown by the plans prepared by the State Highway Department and as established for this street, or streets, from future encroachment along any or all parts of the improvement covered by this agreement, and that all water and sewer pipes, manholes, or fire hydrants and all power, light, telegraph, or telephone poles will be moved, relocated or rearranged, or caused to be moved, relocated or rearranged by the Municipality, and all necessary rights of way for drainage ditches or pipes will be secured to conform to the plans for the proposed improvement and that all of the above will be

done without any expense or cost to the State Highway Department except for those items which are shown on the construction plans for this Project to be adjusted as items in the construction contract or contracts to be awarded by the State Highway Department.

BE IT FURTHER RESOLVED, That the Municipality hereby signifies its intention to faithfully observe the provisions of Chapter 3, Title 46, Code of Laws of South Carolina, 1952, and all amendments thereto relating to the regulation of traffic on the street, or streets, to be constructed, reconstructed, altered or improved as hereinabove identified and further agrees to refrain from placing or maintaining any traffic control devices upon any section of said street, or streets, without having first obtained written approval of the State Highway Department as required in Section 46-302 of the 1952 Code, nor enacting any traffic regulation ordinances inconsistent therewith.
