Harris Davis gave as his opinion that the property would be better handled by a firm in Orangeburg S. C., rather than the agency located in Barnwell, S. C. Ken Middleton advised City Council of the good work done by the Regional Housing Authority in providing decent housing for many people.

Action was postponed until next meeting of City Council on a proposal regarding the conversion of 28 City vehicles to propane fuel usage.

WHEREAS, In accordance with Chapter 3, Title 33, Code of Laws of South Carolina, 1962, and amendments thereto, the South Carolina State Highway Department in cooperation with the Municipality of Orangeburg, proposes to construct, reconstruct, alter, or improve a certain street, or streets, on duly constituted routes in the State highway System, within the corporate limits of said Municipality, according to plans prepared by the State Highway Department, identified as follows:

HHS-000S(938)	U. S. 21 & S-145

U. S. Route 21: Along Boulevard Street from approximately 145' north of Bayne Street (Road S-1003) (Station 0-(1+45), southerly to Station 20+00.

Road S-145: Along Whaley Street from approximately 220' west of Crystal Street (Station 0-(1+70), easterly to Station 7+80.

NOW THEREFORE, Be it resolved that the Municipality of Orangeburg does hereby consent to the construction or improvements of the aforesaid Municipal street, or streets, in accordance with the aforesaid plans, thereby evidencing compliance by the State Highway Department with the provisions of Section 33-172, Code of Laws of South Carolina, 1962; and further, the Municipality, having reviewed the plans for said construction, does hereby approve said plans, as heretofore identified, as provided for in Section 33-173, of the 1962 Code, it being understood that the State Highway Department shall not be liable for damages to property or injuries to persons, as otherwise provided for in Section 33-229, of the 1962 Code, as a consequence of the placing, maintenance, or removal of any utilities by the Municipality, or by others pursuant to permission of the Municipality.

BE IT FURTHER RESOLVED, That the Municipality will legally protect the right of way as shown by the plans prepared by the State Highway Department and as established for this street, or streets, from future encroachment along any or all parts of the improvement covered by this agreement, and that all water, sewer and gas pipes, manholes, or fire hydrants and all power, light, telegraph, or telephone poles will be moved, relocated or rearranged, or caused to be moved, relocated or rearranged by the Municipality, in accordance with plans prepared by the State Highway Department and/or by respective utility companies showing their present

by respective utility companies showing their present and proposed location, and made a part hereof, with provision that pole lines and hydrants be located back of the sidewalk, and all necessary rights of way for drainage ditches or pipes will be secured to conform to the plans for the proposed improvement and that all of the above will be done without any expense or cost to the State Highway Department except for those items which are shown on the construction plans for this project to be adjusted as items in the construction contract or contracts to be awarded by the State Highway Department.

BE IT FURTHER RESOLVED, That the Municipality will furnish the State Highway Department with evidence satisfactory to the Department that the utilities are operating within the Municipality by franchise or other written permission with provision that all necessary relocations of such utilities to accommodate street improvements will be made at no cost to the State Highway Department; that the presence of the utilities over, along or under the street will in no way interfere with construction, maintenance, and safe operations of the street; and that no additional utility installations within the limits of the street improvement from the date of the execution of this agreement will be permitted without approval of the State Highway Department, and that the relocation activities will be coordinated so as to minimize interference with contractor operations.

BE IT FURTHER RESOLVED, That the Municipality hereby signifies its intention to faithfully observe the provisions of Chapter 7, Title 46, Code of Laws of South Carolina, 1962, and all amendments thereto relating to the regulation of traffic on the street, or streets, to be constructed, reconstructed, altered or improved as hereinabove identified and further agrees to refrain from placing or maintaining any traffic control devices upon any section of said street, or streets, without having first obtained written approval of the State Highway Department as required in Section 46-302 of the 1962 Code, nor enacting any traffic regulation ordinances inconsistent therewith.

STATEMENT PERTAINING TO CRIME

AS THE CITY IS PREPARING FOR AN ADDITIONAL INVESTMENT IN OUR RECREATION FACILITIES WITH THE ALBERGOTTI PARK RENOVATION PROJECT AND PLANS FOR CONSTRUCTION OF A NEW NEIGHBORHOOD CENTER AS A COMMUNITY DEVELOPMENT BLOCK GRANT PROJECT ON PEASLEY STREET, I FEEL THAT THIS IS AN APPROPRIATE TIME FOR THE COUNCIL AND STAFF OF THE CITY OF ORANGEBURG TO EXPRESS OUR CONCERN OVER THE CONSTANT PROBLEM OF VANDALISM, THEFT, BREAK-INS, AND DISRESPECT FOR PROPERTY. MEMBERS OF THE PUBLIC SHOULD EXERCISE RESTRAINT AND SHOULD ACT IN A RESPONSIBLE MANNER WHEN USING COMMUNITY FACILITIES. VANDALISM, SOMETIMES IN THE FORM OF CHILDISH PRANKS, COSTS ALL OF US IN THE PUBLIC AND PRIVATE SECTORS AN ENORMOUS AMOUNT OF MONEY. WE ALL SUFFER FROM A CONSTANT PROBLEM OF VANDALISM IN PUBLIC RESTROOMS, ON PLAY GROUNDS AND BALLPARKS, STREET SIGNS, CARS, AND BUILDINGS.

LET THOSE WHO CONDUCT THEMSELVES IN THIS MANNER AND WHO ENGAGE IN THEFTS, BREAK-INS, ETC. BE AWARE THAT THE CITY WILL SPEND CONSIDERABLE EFFORT IN KEEPING THIS ACTIVITY TO AN ABSOLUTE MINIMUM. THE CITY OF ORANGEBURG POLICE DEPARTMENT IS IN THE PROCESS AT THIS TIME OF ADDING FOUR NEW OFFICERS WHICH WILL ALLOW US TO INCREASE PATROLS. WE HAVE THE ASSURANCE OF PROSECUTING AUTHORITIES AND COURT OFFICIALS THAT THEY WILL COOPERATE IN EVERY WAY TO PROSECUTE OFFENDERS. THE POINT HERE IS THAT THE ORANGEBURG COMMUNITY WILL NOT TOLERATE ACTS OF LAWLESSNESS AND THAT THERE IS GOING TO BE COOPERATION ON EVERY LEVEL TO CURB CRIME TO THE GREATEST EXTENT POSSIBLE.

HOLIDAYS

The following, and other days as may be designated by the City Council, are holidays; compensatory time off shall be provided for work done on these days in the same manner as provided for overtime work:

- New Years Day
- July 4th
- Labor Day
- Thanksgiving Day
- Christmas Eve
- Christmas Day

When a holiday falls on a regular assigned day off for a full-time employee, the employee shall be compensated by appropriate time off as provided elsewhere in these rules or such time shall be added to accrued annual leave. Holidays which occur during an annual leave shall not be charged against annual leave.

Whenever any of these holidays shall fall on Sunday, the following Monday shall be observed as the holiday; and, whenever any these holidays shall fall on Saturday, the preceding Friday shall be observed as the holiday. When consecutive holidays fall on Friday and Saturday or on Saturday and Sunday, the holidays will be observed on Friday and Monday. When consecutive holidays fall on Sunday and Monday, the holidays will be observed on Monday and Tuesday.

LEAVE REGULATIONS

GENERAL REGULATIONS

No leave may be anticipated or borrowed against future accumulation. All leave is subject to approval by Department or Division Head. Leave shall be charged against employees in not less than half day units. Regular full-time employees who are separated from the service shall be compensated for leave accrued up to the date of separation.

An employee desiring to use leave time due to illness shall inform his immediate superior of the fact and reason therefor as soon as possible, and failure to do so within a reasonable time may be cause for denial of leave with pay for the period of absence.

Exceptions to this leave policy may be made by the City Administrator or the Department of Public Utilities Manager.

OTHER LEAVES OF ABSENCES

Employees shall be granted leaves of absence for required jury duty. Where time permits, the employee will be expected to work before reporting for jury duty and after being released, if it is before working hours are over.

Leaves with pay may be authorized so that regular employees may attend official meetings, if such leave is approved by Department or Division Heads. Leave with pay may also be granted

for the purpose of allowing a regular employee to engage in official training courses or to participate in other official activities. Leave taken under this provision shall not be charged against leave allowances.

To initially implement this plan, each employee's sick leave would be converted to Leave on the ratio of two days sick leave for one day leave. Base maximum days for leave x 1½ equals new maximum base for leave.

A THIRTY (30) MINUTE LUNCH BREAK WILL BE TAKEN IN THE FIELD AT 12:00 NOON, OR AS CLOSE TO THAT TIME AS WORK PERMITS. A TEN MINUTE BREAK IN THE MORNING AND AFTERNOON SHALL BE OBSERVED AT A TIME DEEMED MOST APPROPRIATE BY THE SUPERVISOR. THIS POLICY SHALL BE ADHERRED TO DURING NORMAL WORKING CONDITIONS. IT MAY BE ALTERED BY A DEPARTMENT HEAD TO ACCOMMODATE ABNORMAL WORK LOADS, CRISIS SITUATIONS, OR AT OTHER TIMES JUDGED NECESSARY BY THE DEPARTMENT HEAD OR CITY ADMINISTRATOR.
