When service has been discontinued in accordance with paragraph 7 above, all charges for services to date become immediately due and payable and service will not be reinstated until payment in full has been made, including the extra charges listed in paragraph 7, and any additional deposit as may be deemed necessary by the Department as listed in paragraph 9.

Paragraph 19: Add a new paragraph to said "Rules and Regulations" which shall be number 19 and which shall read as follows:

19. When a customer desires to have his service terminated or an existing service turned on during normal working hours of the workday of the application and the customer has notified the Department by 2 P.M. of the date requested, every effort shall be made to provide service during normal working hours of the workday requested. If the application is received after 2 P.M., every effort shall be made to provide service during normal working hours of the workday following the date of application. The customer may pay a service charge of \$20.00 to have the service worked in other than normal working hours.

Chief Neil and I take pleasure in sharing a "slice of life" out of the lives of two city employees who performed a good samaritan act to a fellow employee.

On the morning of May 20, 1982, Nicholas Davis of the Orangeburg City Public Works Department pulled the city dump truck he was operating over to the side of the road suffering from severe chest pains. Thinking about prior problems with his heart, he frantically began to seek out someone to help, but within minutes had passed out and fell only a short distance from the truck on the edge of Cannon Bridge Road.

Almost immediately, Mr. Davis's distressful condition was noticed by a passing motorist who acted in an intelligent manner by reporting what he had seen to the City Vehicle Maintenance Garage. Moments after the call for help came into the garage, City Public Works auto mechanic, Owen Priester accompanied by City Police Detective, Joe Keitt, who was having his car repaired by mechanic Priester, responded to the scene.

Upon arriving, they immediately evaluated Mr. Davis's condition as very weak to no pulse or heart beat. At this moment, his life was in their hands. Without hesitation, the two men became partners as they applied knowledgeable CPR technique*. The Orangeburg Regional Ambulance Service had been contacted and responded very quickly to transport Mr. Davis to the hospital.


When I visited Nick on Sunday, May 23, he appeared to be very alert and said he felt fine.

Detective Joe Keitt and Mechanic Owen Priester responded to an emergency situation without hesitation followed by an intelligent act of performing CPR which aided in the saving of Mr. Davis's life.

Chief Neil and I are extremely proud of Police Detective Joe Keitt and Public Works Mechanic Owen Priester and recommend they receive fitting recognition from City Council and community.

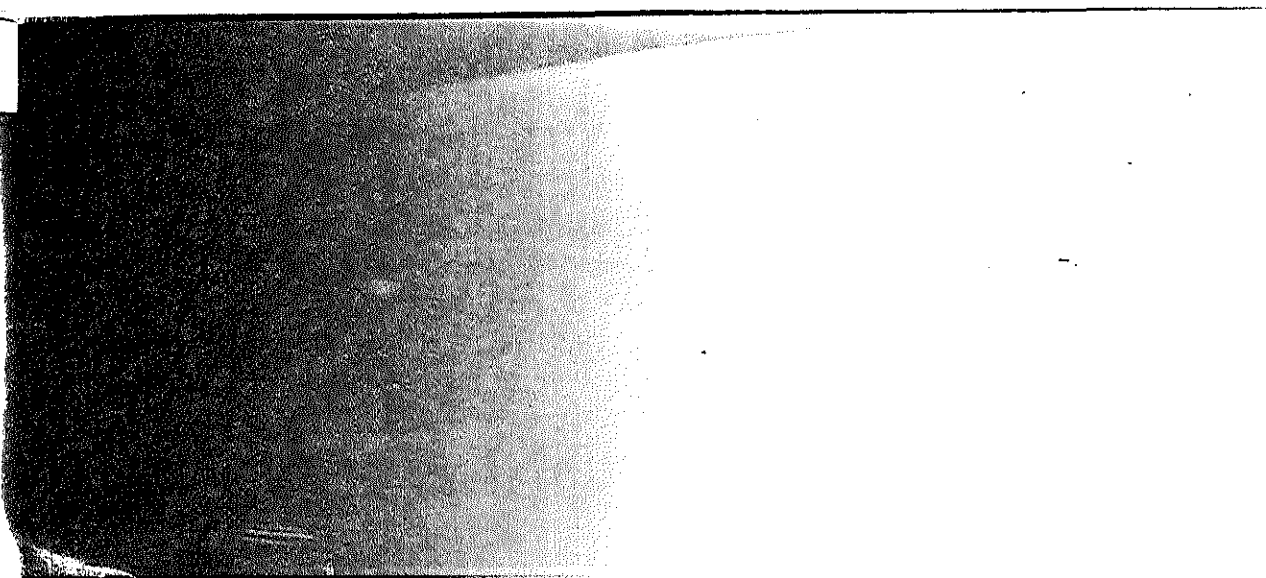
*Along with many Police Department personnel, Detective Joe Keitt had recently completed CPR training instructed by City Fire Department Captain R.O. LaFrance.

Marion Davis, the City of Orangeburg's newly hired horticulturist, gave a presentation to City Council for the purpose of updating Council on the Edisto Gardens. He introduced scheduled, upcoming projects and also presented them with an evaluation of the existing areas. In his presentation, Mr. Davis revealed several areas of particular concern including: water management, such as needed improvement in the present drainage and irrigation system, water wheel modifications, and freeing the ponds from various undesirable plants; ornamental rejuvenation, including dead, dying, and otherwise bothersome plants, structural improvements, referring to needed lighting improvements and/or additional lighting, erecting more signs throughout the gardens and in other areas, improvement of parking, picnic areas, and roads; and landscape design. He also pointed out scheduled repairs to the structural deficiencies in the bridges and sidewalks. Mr. Davis concluded his presentation by informing Council that he would have at least two trained, non paid judges in addition to himself for judging the roses in the experimental rose gardens should the AARS decide to provide the City with plants for a trial garden. He indicated that the AARS had been very receptive to the City's request and that their decision would be finalized in January. He said that he hoped these improvements would generate enthusiasm among the Orangeburg citizens and be a good place for them to enjoy.

Sam Fogle, President and General Manager of the Orangeburg County Fair Fair Association, addressed City Council seeking assistance from the City in digging a 200 foot sewer line at the fairgrounds race-track. Mayor Pendarvis, explaining that such a request fell under the jurisdiction of the Department of Public Utilities, advised Mr. Fogle to contact Mr. Ted Johnson, DPU Manager, with this request.

Mr. Marion Garris, President of the Chamber of Commerce, presented Council with a renovation proposal and expansion of the Chamber building. He explained that the proposed improvements would not

A motion by Mrs. Alexander, seconded by Mr. McCain to pass a resolution affirming the City's support for a grant application for the provision of services to rape victims and for rape prevention by the Tri-County Citizens Against Sexual Assault. The motion passed unanimously.

The Mayor and Council discussed the issue of possibly adjusting the City's percentage contribution to the LEC Detention Center because the 1980 Census changed the population distribution for the two counties and the city. Council decided not to make an adjustment this year because the three governments have already planned their budgets, but that next year an adjustment should be made.

Motion by Mayor Pendarvis, seconded by Councilmember Frierson to remodel the City's Chamber of Commerce building, with up to \$60,000 in Reserve Funds, and to increase the Chamber's rent to a minimum of \$250 per month. After the first year the amount of rent will be indexed to the Chamber's annual budget at a rate of 3.5 percent (which is based on the ratio of \$250 to the Chamber's 1982 budget of \$85,000). The rent is to be reviewed annually. Mr. Tipton was instructed to have a contract written outlining these terms.

Mr. Tipton updated Council on a recent meeting with an FAA representative regarding the status of the VOR/DME maintenance. Mr. Tipton also informed the Mayor and Council that there will be a meeting on September 22, 1982 at 10:00 A.M., at City Hall between Mr. John Howe, the Regional FAA Director, and the City.

Motion by Councilmember McCain, seconded by Councilmember Frierson to increase the Police Department's budget so that it includes two additional officers (four new positions in total) and change the allotments for fringe benefits and equipment for the two additional officers, and to change the Police Department's allotment for guns so that the Police Chief can purchase the type guns he feels needed. Motion passed with four Members of Council voting in favor of the motion and the Mayor voting against it.

Motion by Mayor Pendarvis, seconded by Councilmember Salley, to give second reading to the budget as it was submitted with the exceptions of giving a 7.5 percent cost-of-living increase and reinstating merit raises (with the amount and merit raise procedure to be discussed at a later date), instead of giving a flat 10 percent cost-of-living increase. The funds needed to make up the difference between the expenditures and the revenues would be funded out of the City's reserve and surplus. Motion failed with Councilmembers McCain, Frierson, and Alexander voting against the motion.

Motion by Councilmember Frierson, seconded by Councilmember Alexander to give second reading to the budget as submitted with a 10 percent cost-of-living increase, and with determining how to raise the additional needed revenue at a later time. Motion passed with Councilmembers McCain, Alexander, and Frierson voting in favor of the budget and the Mayor and Councilmember Salley voting against it.







Mr. Tipton, City Administrator, presented to Council the official results from the Orangeburg County Election Commission of the November 2, 1982 Annexation Referendum for final disposition. He explained that this was an advisory referendum in which all registered voters in the proposed area to be annexed, as well as all registered City voters were allowed to participate. A motion by Council member McCain, seconded by Mayor Pro Tem Salley, unanimously approved denial of the annexation petition.

The results of the Curbside Pilot Program was then presented to Council by City Administrator Tipton. Mr. Tipton informed Council that of the 671 questionnaires returned, 544 or 81.1 percent were in favor of continuing the system on a citywide basis, while 116 or 17.3 percent were opposed, and 11 or 1.6 percent had no preference or were undecided. Other favorable facts pointed out by Tipton as a result of the 90 day trial program, included: fewer employee injuries; reduction in landfill trips, by 50 percent, due to the new equipment's capability of holding more refuse; cleaner and more mechanized; minimal cart maintenance; reduction in the workforce; and most importantly the savings.

Numerous City residents attended the Council Meeting expressing their concern on the Curbside issue.

A motion by Council member Frierson, seconded by Mrs. Alexander, unanimously approved city wide implementation of the curbside cart collection system used in the pilot program.

A motion by Mayor Pendarvis, seconded by Mayor Pro Tem Salley, unanimously approved a millage rate of 49 mils for the 1982-1983 Fiscal Year.

A motion by Mrs. Alexander, seconded by Mayor Pendarvis, unanimously approved third and final reading of An Ordinance to Further Provide for the Collection of Current and Delinquent Taxes in the City of Orangeburg.

City Administrator informed City Council that the conversion of the City's garbage pickup service to the Curbside System would cost less than previously projected. He attributed the approximate \$16,500 savings to negotiations with various vendors in lieu of a bid process. Mr. Tipton recommended the purchase of two Heil 5000 Packer Bodies mounted on an American LaFrance Cab and Chassis. A motion by Mayor Pro Tem Salley, seconded by Councilmember McCain, unanimously approved purchase of the two vehicles.

Following a brief discussion on the purchase of carts, Mayor Pro Tem Salley moved for the purchase of 4,500 carts, but his motion was not seconded. A motion by Mayor Pendarvis, seconded by Councilmember Frierson, unanimously approved purchase of 4,280 Rubbermaid carts at \$38 per cart.

Mr. Tipton presented proposals for Council's consideration for recodifying the City's Code of Ordinances, which as he explained, had not been recodified since 1969. He recommended the approval of Coded Systems' proposal, however, due to concerns of City Attorney, Mr. Tipton recommended deferral of this proposal.

A motion by Council member Frierson, seconded by Council member Alexander, unanimously approved applying for 1983 Community Development Funds through the South Carolina Governor's Office for completion of a section of the Sunnyside Canal which runs between Summers and Oak Streets.

Mr. Ted Johnson, Department of Public Utilities Manager, brought several matters to City Council's attention: 1) He informed Council that the City had been award a grant in the amount of \$163,630 to be applied toward the Rotron Water Project; 2) He stated that the Department of Public Utilities was in the process of taking bids for the

expansion of the water plant; 3) He informed Council that the IBM Corporation had solicited purchase of a DPU Utility Computer Program for a total of \$5,000.






