After this conference Council proceeded with regular bus ness.

Dec 24th date for second meeting in December being Christmas Eve this meeting was dispensed with.

City Treas submitted financial report of receipts and disbursments for the month od December which was received as information.

Petition of Salley Cycle Co to install free air station on sidewalk in front of their place of business 87 E.Russel Street was granted. To be installed under supervision of City Engineer.

Petition from certain Dealers in Coal asking that License granted Coal dealers not having scales on which to weigh coal sold by them or who do not weigh coal sold by them be materially increased was read and action postponed until Business License for 1921 is under consideration.

Committee of Lumber men were present asking for reduction of License on Lumber Yards. They were requested to put their request in writing and submit same.

City Overk under instruction from Council having advertised for bids for stable manure and Street Sweepings forymen commencing Jan.1,1921, one bid was received from Mr.E.A.Bultman offering \$75.00 for same. His bid was accepted

Vote Yea The Mayor, Councilman Watson and Sifly.

Mr Willie Wannamaker, Foreman Elliott Hook and Ladder Co requested that City install some system of sewerage for tiolet and bath for use of firemen in Fire Station of the Elliotts.

Meeting January 14 1920 continued.

He was advised to secure bids from regular licensed Plumbers for necessary plumbing and submit same to City Council at a future meeting.

Chief Fischer asked Council for additional hose as he had none in reserve and only 3100 feet of servicable hose in commission. He asked for 1000 feet additional. Also advised the necesity of a hose drying rack. Councilman Watson was requested to investigate and report on this at next meeting. City Clerk instructed to ask dealers for bids for 1000 feet of hose by next meeting.

Mr.Yarborough Secty Chamber oo Commerce, was present and verbally submitted to Council suggestions relative to securing Webster Property adjacent to Cemetary for the purpose of a Park. He was told that Council would be ready to discuss this matter with him when it was presented in writing ,giving all information necessary as to cost &c .

Health Commissioner Erigham discussed with council the necessity of formulation and passeing certain health regulations and ordinanced suggested by him and approved by Board of Health.

Council decided to call an extra meeting to pass on same requesting the Board of Health to attend said meeting.

Mr. Watson reported the dangerous condition of the veranda attached to St Joseph Hotel. The Mayor stated that he would give this his personal attention.

City Attorney Bowman was requested to secure for Council certain information relative to Orangeburg Railway.

Dity Clerk was instructed to write Standard Cil Co requesting removal of rejected Oil Tank on North Railroad Ave. near Jennings-Bowman Store.

The Mayor was authorized to borrow from the Banks of thevert the City such funds as are necessary for use of City at present.

He has to make the appointment but it has been his custom to request Council to nominate said Board for the City Township. This was received as information to be taken up for action at a later period.

Mr.W.H.Jennings submitted claim against City for damage to his automobile by City Garbage truck. He was requested to have car at City Hall at ten A.M. some morning that Mayor could inspect same in order to adjust liability of City if any liability rested against the City.

Communication from Chamber of Commerce, containing resolutions condemning the management of City Electric Plant was x read and Næssrs V.J.Hill President and Holt Scarborough Secty of that body were present representing that body. Coun cilman Watson

requested Mr. John F. Pearson Supt. of Plant to explain to Council and these gentlemen making these complaints the cause of aparent poor service upon several occasions lately , which he attributed to the poor class of coal now being received from the mines and also boiler troubles the load for one bioler being at the peak and it costs City \$30.00° to fire up the remaining boiler for only three hours service. The Mayor said that it seemed that the resolution from Chamber of Commerce has been passed before that body had made any effort to secure information as to trouble complained of and that while City Council was always ready to receive and give earnest consideration to complaints and criticisms of citizens regarding inefficiency or carelessness of management of any depart ment of City Government, yet, in Justice to the City Officials parties feeling agrieved should at least make some investigations before passing drastic resolutions such as inder consideration at this time.

Communications from Orangeburg Retail.Merchants Association requesting Council to Offer a reward for the apprehention of parties committing recent roberies around the City and also,

That peddlers and patent medicine vendors selling on the streets and ways of the City be refused license by Council.

The Mayor advise Mr.Yarborough who represented the Retail merchants Association as Secty, The Council and Police Department were on the job as to recent roberies and declined to offer reward as requested; as to licenseing pedlars and patent medicine vendors this would be considered while framing up License Ordinance for year commencing April 1,1921.

Health Commissioner Brigham submitted request from Board of Health for crude oil for oiling ditches and other place where mosquitoes breed, a sprayer and man to operate same, Also Oil for use on Street. also, bid by Texas Co for oil at 12¢ per Gal.F.O.B Charleston S.O. Council authorized the purchase of necessary oil from Texas Co. for mosquito elimination but does not deem it practical for use on street at this time.

Following resolution relative to rules and regulations of Board of Health were passed.

It is ordered that said rules and regulations of the said Board of Health complete in form in which they were confirmed, pap proved and passed by City Council, shall remain on file with the City Clerk, open to public inspection, for at least one week before final adoption and ratification.

An Ordinance Authorizing and Directing the Issuance and Sale of Certain Municipal Coupon Bonds and Making the Certain Prescriptions Required by Law to be Made Concerning the Issue and Sale of Said Bonds.

Be it resolved and ordained by the City Council of the City of Orangeburg, South Carolina, in regular council assembled:

Section 1.-nThat in pursuance of an ordinance or resolution adopted by City Council on December 12, 1919, authorized to be issued and directing that the coupom bonds, authorized to be issued and sold by a special Municipal Election held by the qualified electors of the City of Orangeburg on November 4,1919, "shall be issued and sold by said City of Orangeburg from time to time and in such blocks or amounts or series as shall be determined by the City Council of the City of Orangeburg. South Carolina, that the City of Orangeburg South Carolina by its City Council do forthwith issue and sell the following coupon bonds of the issues authorized to be issued and sold by said Special Municipal Election:

First. Three hundred thousand (\$300000.00) dollars of coupon bonds of the issue of six hundred, ten thousand dollars, authorized to be issued for the purpose of paying for permanent improvements on the streets of the City of Orangeburg, South Carolina, to be known and designated as "Street Improvement Bonds" of the City of Orangeburg, South Carolina.

Second-Forty thousand dollars of coupon bonds of the issue of fifty thousand dollars authorized to be issued for the purpose of enlarging and extending the sewerage, and sewerage system of the said City of Orangeburg, South Carolina, to be known and designated as "Sewerage Bonds" to the City of Orangeburg, South Carolina, being the balance of the whole issue authorized for sewerage, and sewerage system.

Section 2. - That the proceeds of the sale of each of said issue of bonds shall be expended for the several purposes for which they were severally sutherized.

shall run for forty years with the privilege of redemption by said City after twenty years, and said bonds shall bear nutura at the rate of five and onfacif per centum per amoun, payable semi-angually from date of issue and shall be dated April 1, 1921, and shall be of the denomination of one thousand dollars each.

Section 4. That for the purpose of paying the interest on said bonds; and for the purpose of creating a Sinking fund for the payment and redemption of said bonds at the expiration of forty years, a sufficient tax be levied and collected annually upon all the taxable property in the City of Crangeburg. by the City Council of Crangeburg, and that said tax be levied and collected annually in the same manner as other taxes of said City are levied and collected.

Section 5.- That said bonds be sold by the City Jouneil of Orangoburg to the best advent go, for the said City after due advertisement of same, and shall be issued in such legal form, and shall be made payable at such place and shall have such sefeguerd placed around them as shall be agreed upon by said City Council, and the purchaser of said bonds.

An Ordinance to Require Railroad Companies to Construct and Maintain Safe and Suitable Crossings Within the Corporate Limits of the City of Orangeburg

Be it ordained by the City Council of the City of Orangeburg in regular council assembled:

Section 1. That all railroad corporations, whose lines of railroad pass through the City of Orangeburg be and each of them are hereby required to construct and maintain paved crossings at points where paved streets cross said lines of railroad or side tracks from the same, and to construct and maintain plank crossings at points where dirt streets cross said lines or side tracks of said railroads. Crossings so constructed shall extend the entire width of the street from building line to building line and shall extend eighteen (18) inches on the outside of each rail and cover all space between the rails.

Section 2. That all crossings which do not now comply with Section 1 of this ordinance must be made to conform thereto within sixty days from the adoption hereof.

Section 3. That any such railroad corporation, failing to comply with the provisions of this ordinance, shall for each and every offense be deemed guilty of a misdemeanor and upon conviction therefor by the Recorder, Mayor or Acting Mayor, be sentenced to pay a fine of not exceeding One Hundred (100) Dollars; provided that said fine may be collected by the City of Orangeburg by suit in any Court of competent jurisdiction in this State.

Section 4. That this ordinance must be construed to be in addition to and not in repeal of Section 95 of the Revised Ordinances of the City of Orangeburg.

#### MUNICIPAL PROCLAMATION.

By Power vested in me by Sec. 90 of Chapter of the revised Ordinances of the City of Orangeburg, I do heleby suspend so much of Section 90 as forbids "the firing and discharging crackers, sky rockets, Roman candles and other fireworks in the city of "rangeburg" for a period between 9 O'clock P.M. December 24th 1921 and 12 O'Clock Midnight Sanuary 2,1922 (Sundays Excepted), subject to following limitations and restrictions: to wit;

13t. That on Russel Street from Doyle to Windsor Street the firing and discharging of fire works shall be restricted to the time between 7 0'clock P.M. to 7 0'clock A.M.; except that on Thurk-day Monday, December 26th, the restriction as to time and place above specified shall be removed.

2nd. That the discharging of fireworks of any kind on any or all parts of the streets or premises adjoining the "Cotton Yard" is hereby forbidded at all times.

3rd. The exploding of dynamite cartridges, or bombs, or other devises the explosive force of which is dynamite, also the shooting of <u>TOY CAP PISTOLS</u> is hereby positively and strictly forbidden any where within the City of Orangeburg under pain of severe penalties.

4th. Merchants, Manufacturers and all other citizens are hereby strictly enjoined to remove at once any and all litter and combus table matter from their premises and to this end the Police Department is instructed to report all violations of the Ordinances of the City and this City relative to above matter and are charged with the enforcement of this proclamation and the Ordinances governing the discharging of fireworks and firearms within the City of Orangeburg S.C.
