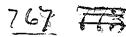

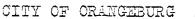

On behalf of the City of Orangeburg we make you the following proposition:

We will obtain a conveyance to the County, in order that the Commission may build a new Court House thereon, of that lot or tract of land situate on the corner of Amelia Street and Pitthan Alley, measuring on Amelia Street about 220 ft. and on Pitthan Alley about 278 ft., and bounded on the Northeast by the Presbyterian Church property, on the Southeast by an alley separating said lot from lots of W. A. Livingston, Crum Bros., Dr. D.J. Hydrick, T. B. Bryant and others, on the Southwest by Pitthan Alley, and on the Northwest by Amelia Street.

We have made arrangements by which this property may be purchased by us and conveyed to the County for the use of the Court House Commission, and the City will pay for this property and any expenses necessary in obtaining titles thereto and have same conveyed to the County.

In addition, the City of Orangeburg will pay to Orangeburg County Court House Commission the sum of \$35,000. in cash to be used in the construction of a new Court House, the cash payment to be made on or about April 1st, 1927, while the conveyance of the real estate may be made at any time after thirty days from this date that it may be desired by the Commission.

In consideration of which the Commission will convey the present Court House site to the City of Orangeburg on the condition that it not be used for business or commercial purposes, but only for a public park for the benefit of the citizens of the City of Orangeburg and of the County of Orangeburg, and the City Council will beautify or improve the square as may be most convenient and suitable for such purposes.

The use of the present Court House shall be reserved by the Commission and possession only turned over to the City after completion of the new Court House building. The removing of the present building is to be undertaken thereafter by the City of Orangeburg.

At a meeting of the County Court House Commission today, a resolution was adopted accepting the offer of the City Council made to it on October 19th. Under this offer the City is to purchase and convey to the County the lot on Amelia Street and Pitthan Alley, and bounded on the other sides by the extention of St. Paul Street and the Presbyterian Church property. In addition, the City is to pay the Commission \$35,000. for use in building a new Court House. In consideration of the above, the Court House Commission will convey the present Court House site to the City of Crangeburg for the purposes stated in your proposal.

The Commission desires that title to this property be obtained as soon as possible and without delay, and will be glad to have you take steps at once to this end.

The Commission has requested Mr. J. R. Salley to represent it in the preparation of its title to the property and in the examination of the records as to it. They would be very glad if you will turn your end of the matter over to the City Attorney and have him take such steps as may be necessary to carry out your agreement, the details of which will be handled by Mr. Salley on behalf of the Commission.

Minutes of Special meeting of the City Council of Orangeburg, S. C., held on Thursday, December 2, 1926, at 3 p.m. at the office of Councilman A. C. Watson. Present:-

The Mayor, Honorable R. H. Jennings.

Councilmen, A. C. Watson J. M. Sifly.

The meeting was called to order by the Mayor, who stated that the purpose of the meeting was to consider and take official action upon negotiations which had begun between the City Council and the Orangeburg County Court House Commission.

The purpose of the negotiations was the possible sale of the present Court House Square, belonging to the County of Orangeburg, to the City of Orangeburg for limited use as a public park and not for commercial or business use.

The Mayor stated that on the 19th day of October, the Council during the progress of the negotiations, submitted to the Orangeburg County Court House Commission a proposition by which the City offered to convey to the County a new site for the Court House and the sum of Thirty Five Thousand (\$35,000.00) Dollars in cash as the purchase price for the present Court House site, as will be more fully shown by the written proposition attached to these minutes and made a part thereof and marked Exhibit No. 1.

Also, attached to and made a part of these minutes are letters exchanged between the Orangeburg County Court House Commission and the City of Orangeburg during the course of the negotiations, which include:

(1) Letter of the Court House Commission to the Mayor, dated November 3rd, 1926, marked Exhibit No. 2.

(2) L_e tter from the City Council to the Court H_ouse Commission, dated November 5, 1926, and marked Exhibit No. 3.

(3) Letter of the Court House Commission to the Mayor, dated December 1st, 1926, and marked Exhibit No. 4.

Councilman Watson thereupon offered a resolution confirming the negotiations. See Resolution attached to and made a part of these minutes, marked Exhibit No. 5. This resolution was passed by the following vote:-

The detailed execution of the agreement was referred to the City Attorney with instructions to prepare the necessary papers to enable the City to carry out its part of the agreement. He was further instructed to investigate the legal title of all property to be acquired by the City for the purpose of conveyance to the Orangeburg County Court House Commission and to confer with the attorney for the Court House Commission, taking such steps as may be legally necessary to protect the interests of the City of Orangeburg and safeguard it against any possible loss.
