

AN ORDINANCE TO AMEND THE BUSINESS AND
PROFESSIONAL LICENSE ORDINANCE
AS ADOPTED MARCH 6, 1962

BE IT ORDAINED by the Mayor and Councilmen of the City
of Orangeburg, S. C., in council assembled:

That the ordinance to regulate licenses in the City of
Orangeburg, South Carolina, for the year 1962 and thereafter un-
til amended or repealed by the City Council be amended in the
following respects:

1. That the license regulation under TELEPHONE EX-
CHANGES, on page 17 of the Business and Professional License
Ordinance, be repealed, and amended to as to read:

*MAY 9 1963
MINUTES
RECORDED*

"TELEPHONE EXCHANGES
"On Gross receipts not exceeding \$25,000-----\$1,200.00
"On each additional \$1,000 or fraction thereof- 1.50
"For local service rendered exclusively in the
City of Orangeburg, and not including any busi-
ness done for the U. S. Government or its
officers or agents."

2. That there be added a new section known as "Section
5B, immediately following Section 5A, which begins on page 18, to
read as follows:

"Section 5B. In the event that the nature and descrip-
tion of the business to be designated cannot be satisfactorily
determined between a wholesale and retail business, for license
tax purposes, then a retail license will be charged on all of
the business done; provided, however, where a retail and whole-
sale business can be clearly separated, then separate applications
for license taxes may be filed.

AN ORDINANCE TO REQUIRE ALL PERSONS, FIRMS OR CORPORATIONS SELLING MERCHANDISE WITHIN THE CITY OF ORANGEBURG, S. C., PRODUCED IN COMMUNIST COUNTRIES TO DISPLAY AN ADVERTISEMENT IN THE FORM HEREINAFTER SET FORTH

BE IT ORDAINED By the Mayor and Council of the City of Orangeburg, South Carolina, in council assembled:

Section I. Every person, firm or corporation selling merchandise within the City of Orangeburg, S. C., which has been produced in communist countries shall display conspicuously in the place of business a sign with lettering, which lettering shall be at least six (6) inches in height and one-half (1/2) inch in width reading as follows:

"This place of business sells merchandise produced in Communist Countries." Said signs to be obtained without cost from the City Treasurer.

Section II. The following are communist countries: Union of Soviet Socialist Republics, Red China, Czechoslovakia, Yugoslavia, Poland, Hungary, Cuba, Lithuania, East Germany, Bulgaria, and Romania. Other countries may be added from time to time.

Section III. Any person violating the provisions of this ordinance shall be subject to a fine not to exceed One Hundred (\$100.00) Dollars or imprisonment not to exceed thirty (30) days.

This ordinance shall become effective three (3) weeks after the date of its passage.

AN ORDINANCE TO AMEND AN ORDINANCE AS ENACTED BY THE CITY COUNCIL OF THE CITY OF ORANGEBURG ON THE 18TH DAY OF MAY A.D., 1954, FOR THE PURPOSE OF REGULATING AND RESTRICTING WITHIN THE CORPORATE LIMITS OF ORANGEBURG, S.C., THE HEIGHT, NUMBER OF STORIES, AND SIZE OF BUILDINGS AND OTHER STRUCTURES, THE PERCENTAGE OF LOT THAT MAY BE OCCUPIED, THE SIZE OF YARDS, COURTS, AND OTHER OPEN SPACES, THE DENSITY OF POPULATION AND THE LOCATION AND USE OF BUILDINGS, STRUCTURES, AND LAND FOR TRADE, INDUSTRY, RESIDENCE, AND OTHER PURPOSES.

BE IT ORDAINED by the Mayor and Councilmen of the City of Orangeburg, in Council assembled, and by authority of the same:

That that portion of the above ordinance entitled "Section 3, ESTABLISHMENT OF ZONING DISTRICTS" be amended to make the following change in the District Classifications:

Change to "B-1 Business" that area now classified as "A-2 Residential" in the block between Sellers, Elliott, Glover and Southern Railway; with no change in the area within this block now classified as "D-1 Industrial".

So that said section of the above Ordinance, as amended, shall read in its entirety as follows:

Section 3. ESTABLISHMENT OF ZONING DISTRICTS.

For the purpose of promoting the public health, safety, morals, convenience, order, prosperity, and general welfare, the City is hereby divided into (5) five types of zoning districts as follows:

"A-1" Residence District
"A-2" Residence District
"B-1" Retail Business District
"C-1" Central Business District
"D-1" Industrial District

The boundaries of such districts are as shown upon the authenticated zoning map dated May 18, 1954 with revisions dated as follows:

1. April 19, 1955 (to include area annexed March 1, 1955)
2. December 6, 1955 (to include area annexed August 16, 1955)
3. January 17, 1956 (to change 870 and 880 Russell SE from "A-2" to "B-1")
4. January 17, 1957 (to include area annexed September 4, 1956)
5. May 9, 1957 (to include area annexed January 15, 1957)
6. February 18, 1958 (to change from classification "B-1" to "C-1" area between Church, St. Paul and Doyle)
7. May 19, 1959 (to include additions and changes recommended by Planning Commission)
8. May 19, 1959 (to include area annexed December 16, 1958 - Colonial Heights)
9. June 16, 1959 (to change from "A-2" to "B-1" the area between Glover, Maple, Windsor and Calhoun)
10. August 4, 1959 (to change No. 643 Carolina NE from "A-2 Residential" to "B-1 Business")
11. July 5, 1960 (to change from "A-2" to "B-1" area between Broughton and Middleton)
12. March 7, 1961 (to include area annexed June 7, 1960 - Gressette Woods)
13. August 1, 1961 (to change from "A-2" to "B-1" area between Amelia, Russell, Centre and Boulevard - except frontage on Amelia from Centre to Lowman)
14. _____ (to change to "B-1 Business" the area now classified as "A-2 Residential" in the block between Sellers, Elliott, Glover and Southern Railway)

The zoning Map, with above restrictions, is on file in the office of the City Clerk, such authenticated map and all notations, reference and other things shown thereon and all amendments thereto are made a part of this ordinance. The boundaries of the various districts as shown on the Zoning Map are lot lines; the center lines of streets or alleys or such lines extended; the center lines of railway rights-of-way; the center lines of natural boundaries such as streams; the corporate limits of the City; or in case none of the foregoing are applicable, then the boundaries shall be determined by use of scale of such map.

Any area hereafter annexed to the City shall be in no zoning classification until added into this ordinance after duly advertised public hearing in accord with State Law.

AN ORDINANCE TO RAISE SUPPLIES AND MAKE APPROPRIATIONS
TO MEET THE LIABILITIES OF THE CITY OF ORANGEBURG, S.C.,
FOR THE YEAR COMMENCING JANUARY 1, 1963 AND ENDING
DECEMBER 31 1963

BE IT ORDAINED, by the Mayor and Councilmen of the City of
Orangeburg, S.C., in Council assembled and by authority ofn
the same.

That for the purpose of raising supplies and meeting the
ordinary expenses of the City of Orangeburg S.C., for the year
commencing January 1 1963, and ending December 31 1963 that a tax
of Fifty Mills be and the same is hereby assessed on each
dollar of the assessed value of all real estate and personal property
within the City of Orangeburg S.C., except as such which is
exempt from taxation by law.

Tax levied under this Ordinance shall be due and payable
at the office of the City Clerk and Treasurer, in the Municipal
Building of the City of Orangeburg S.C., from the fifteenth day of
October 1963, until the twenty seventh day of November 1963,
from the hours of 9 A.M. to 5 P.M. Mondays through Fridays, and
9 A.M. to 12 Noonnon Saturdays, Sundays excepted.

After November 27th, 1963 a penalty of fifteen (15) percent
shall be added to all unpaid taxes until December 31 1963.
on January 1st, 1964 executions shall be issued on all unpaid
taxes by the City Clerk and Treasurer and delivered to the
Delinquent Tax Collector and additional costs of \$ 2,00 added
to the penalties already incurred.

That for the purpose of carrying into effect this Ordinance
the City Clerk and Treasurer is hereby authorized, empowered
and directed to take such steps and do all things that may be
necessary thereto as is provided by Law and the Ordinances of
the City of Orangeburg S.C.,

AN ORDINANCE TO REQUIRE PERSONS ENGAGING
IN PICKETING, PATROLLING OR OTHER ACTIVITY
UPON THE SIDEWALKS AND STREETS OF THE CITY
OF ORANGEBURG OR PERSONS DIRECTING SUCH
PICKETING, PATROLLING OR OTHER ACTIVITY TO
REGISTER WITH THE CITY OF ORANGEBURG AND TO
PRESCRIBE OTHER REQUIREMENTS IN CONNECTION
WITH SUCH ACTIVITIES.

WHEREAS, City Council of Orangeburg has investigated the problems which arise in connection with picketing, patrolling and similar activities by individuals upon the sidewalks and streets of the City of Orangeburg; and

WHEREAS, City Council has determined that in connection with picketing, patrolling and other activities designed to acquaint the public with the views of the participants, it has been and is often necessary to provide additional police protection in order to preserve and maintain the peace and good order of the City of Orangeburg; and

WHEREAS, City Council has determined that information relative to individuals picketing, patrolling or conducting other like activities in the City of Orangeburg would be helpful and necessary in order to assist the officials and Police Department of the City of Orangeburg in providing protection for all of the citizens and in preserving and maintaining the peace and good order of the community, NOW, THEREFORE,

BE IT ORDAINED By the Mayor and Councilmen of the City of Orangeburg, in Council assembled:

Section 1. Any person or persons who shall picket, patrol or conduct similar activities in and upon the sidewalks and streets of the City of Orangeburg, or on the premises or in front of any factory, store or business establishment in the City of Orangeburg and any person or persons immediately directing or controlling such picketing, patrolling or similar activities, shall file with the City of Orangeburg, at the office of the Chief of Police, prior to such picketing, patrolling or similar activity ~~beginning~~, the following information, which shall be prepared in duplicate, the original of which will be

left with the Chief of Police or at his office, and the duplicate will be carried by the individual filing same, at all times:

- (a) Name.
- (b) Permanent address.
- (c) Orangeburg area address.
- (d) Place being patrolled or picketed, giving street address and street number, if available.
- (e) Hours and days during which pickets or patrols will be maintained.
- (f) Purpose of such picketing or patrolling.
- (g) Name of Employer and amount of compensation, if any, to be received for such picketing, patrolling or other similar activity.
- (h) Name and address of parents or guardian of any person under the age of 21.

Section 2. All persons required to file the reports hereunder shall file same in accordance with the terms of this Ordinance, and, at least once each month, on or before the first day of each calendar month during the continuance of such picketing, patrolling or other similar activity. The report required hereunder shall be sworn to before a Notary Public for South Carolina.

Section 3. Any person failing to file the report required hereunder or any person filing a false report hereunder shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed One Hundred (\$100.00) Dollars or thirty (30) days in jail. Each and every day during which a person pickets, patrols or conducts such similar activities in front of a business establishment or upon the streets or sidewalks of the City of Orangeburg and fails to comply with this

Ordinance shall constitute and be a separate violation.

Section 4. If any part of this Ordinance shall be held unconstitutional or invalid, such unconstitutionality or invalidity shall not affect the remainder of this Ordinance.
