AN ORDINANCE TO AMEND AN ORDINANCE AS ENACTED BY THE CITY COUNCIL OF THE CITY OF ORANGEBURG ON THE 23RD DAY OF FEBRUARY A.D., 1954 FOR THE ADOPTION OF THE NATIONAL PLUMBING CODE.

BE IT ORDAINED by the Mayor and Councilmen of the City of Orangeburg, in Council assembled, and by authority of same:

That Chapter 10, "WATER SUPPLY AND DISTRIBUTION" be amended by adding the following so that the amended section shall read in its entirety as follows:

> "All water heaters shall be provided with an approval selfclosing (levered) water pressure relief valve and temperature relief valve or combination thereof. Such valves shall be installed in the shell of the water heater tank or may be installed in the hot water outlet, provided the thermobulb extends into the shell of the tank, and in all cases installed at the highest practical point. For installations with separate storage tank, said valves shall all be installed on the tank and there shall not be any type of valve installed between the water heater and the storage tank. Where in the opinion of the Building Official, safety valves are required, they shall be installed in accordance with said decisions.

Temperature and pressure relief valves, or combination thereof, shall bear the label of the AGA, or ASME, with thermo-setting of not more than 210°F. and pressure setting not to exceed the tank manufactuere's rated working pressure. The relieving capacity of these two devices shall equal or exceed the heat in-put to the water heater or storage tank."

AN ORDINANCE TO IMPOSE AND REGULATE LICENSES IN THE CITY OF ORANGEBURG, SOUTH CAROLINA, FOR THE YEAR 1965 AND THEREAFTER UNTIL AMENDED OR REPEALED BY THE CITY COUNCIL.

BE IT ORDAINED by the Mayor and Councilmen of the City of Orangeburg, S. C., in Council assembled.

Section I. That the licenses taxes hereby imposed for the privilege of carrying on the business, trade, profession, or doing the acts named or described herein by reference to the Business License Ordinance ratified by the City Council, March 6th, 1962, of Sections 21-1 through 21-19 of the City Code, 60 000 within the corporate limits of the City of Orangeburg, from the first day of April, 1965, to the thirty-first day of March, 1966, inclusive, and annually thereafter until repealed or amended, shall be the same as for the period from the first day of April, 1962, to the thirty-first day of March, 1963, inclusive. The schedule of licenses adopted by that Ordinance of the City of Orangeburg entitled "AN ORDINANCE TO REGULATE LICENSES IN THE CITY OF GRANGEBURG, SOUTH CAROLINA, FOR THE YEAR 1962 AND THEREAFTER UNTIL AMENDED OR REPEALED BY THE CITY COUNCIL ratified on the 6th day of March, 1962, by the City Council, is hereby adopted as a schedule of licenses for the year running from the first day of April, 1965, to the thirty-first day of March, 1966, inclusive; said schedule of licenses is printed "BUSINESS AND PROFESSIONAL LICENSE ORDINANCE, 1962, as adopted March 6, 1962, for the City of Orangeburg.

Section 2. If any section or portion of a section of the Ordinance or the license tax prescribed herein, for any particular trade, business or profession be declared unconstitutional or declared invalid for any reason, such shall not in any way affect or invalidate any other section or portion of the Ordinance other than that declared invalid.

Section 3. All Ordinances or parts of Ordinances conflicting with the provisions of this Ordinance are hereby repealed, and this Ordinance shall remain in effect until amended or repealed by the City Council.

- 2. Change from "A-2 Residential" to "B-1 Business" the following property: all that area lying between Henley NE, Sunnyside Canal and Mary NE and bounded as follows beginning on the East by side of the 300 Block of Summers NE and extending Northernly 459 feet to Sunnyside Canal; Easterly along Sunnyside Canal to the projection of the West side of Mary NE where it intersects Sunnyside Canal approximately 402.8 feet; Southernly along the Western edge of the 300 Block of Mary NE 534 feet and 2 inches and Westerly along the Northern edge of the 500 Block of Henley NE 400 feet to Summers NE or the point of the beginning.

AN ORDINANCE TO AMEND SEC. 28-3 of CHAPTER 28 OF THE CODE OF THE CITY OF ORANGEBURG, SOUTH CAROLINA, 1960, IN ORDER TO STRIKE CERTAIN WORDS THEREFROM

The conditional license herein authorized is subject to the good conduct of the owner, manager, or operator of the said pool room and the maintenance of good order in the said pool room and upon the provision that the said pool room be closed not later than eleven P.M. of each day; it is also specifically provided that no license will be granted to any pool room not located on the first floor of any building, or to a pool room which contains blinds, curtains, partitions, or other devices which prevent clear vision of the entire pool room from the front of the building in which the said pool room is located."

AN ORDINANCE TO RAISE SUPPLIES AND MAKE APPROPRIATIONS TO MEET THE LIABILITIES OF THE CITY OF ORANGEBURG, S. C., FOR THE YEAR COMMENCING JANUARY I, 1965 AND ENDING DECEMBER 31, 1965.

BE IT ORDAINED by the Mayor and Councilmen of the City of Orangeburg, S. C., in Council assembled and by authority of the same.

That for the purpose of raising supplies and meeting the ordinary expenses of the City of Orangeburg, S. C., for the year commencing January 1, 1965, and ending December 31, 1965, that a tax of fifty (50) mills be and the same is hereby assessed on each dollar of the assessed value of all real estate and personal property within the City of Orangeburg, S. C., except as such which is exempt from taxation by law.

Tax levied under this Ordinance shall be due and payable at the office of the City Clerk and Treasurer, in the Municipal Building of the City of Orangeburg, S. C., from the fifteenth (15) day of October, 1965, until the twenty fourth (24) day of November, 1965, from the hours of 9 A. M. to 5 P. M., Mondays through Fridays, and from 9 A. M. to 12 Noon on Saturdays. Sundays excepted.

After November 24th, 1965, a penalty of fifteen (15) percent shall be added to all unpaid taxes until December 31, 1965. On January 1st, 1966, executions shall be issued on all unpaid taxes by the City Clerk and Treasurer and delivered to the Delinquent Tax Collector, an additional costs of \$2.00 added to the penalties already incurred.

That for the purpose of carrying into effect this Ordinance the City Clerk and Treasurer is hereby authorized, empowered and directed to take such steps and do all things that may be necessary thereto as is provided by law and the Ordinances of the City of Orangeburg, S. C.
