Section 3. All Ordinances or parts of Ordinances conflicting with the provisions of this Ordinance are hereby repealed, and this Ordinance shall remain in effect until amended or repealed by the City Council.

ORDINANCE 1974-7

AN ORDINANCE TO AMEND SECTION 27-16 OF THE CODE OF ORDINANCES, CITY OF ORANGEBURG, SOUTH CAROLINA, ADOPTED OCTOBER 21, 1969, RELATING TO SERVICE CHARGES TO BE DETERMINED AND PAID FOR THE PRIVILEGE OF USING THE PUBLIC SEWER SYSTEM OF THE CITY.

BE IT ORDAINED By the Mayor and Councilmen of the City of Orangeburg, in Council assembled and by authority of the same:

SECTION 1: Amend sub-paragraph (a) of Section 27-16 of said Code by striking said sub-paragraph in its entirety and inserting in lieu thereof the following:

> "(a) <u>Amount</u>. All persons who shall install, use, maintain or have connected with the public sewer system of the City of Orangeburg one or more flush toilets or urinals shall pay a service charge therefor at such rate as may be determined from time to time by Resolution duly adopted by the City Council."

AN ORDINANCE TO RAISE SUPPLIES AND MAKE APPROPRIATIONS TO MEET THE LIABILITIES OF THE CITY OF ORANGEBURG, S.C., FOR THE YEAR COMMENCING JANUARY 1, 1974 AND ENDING DECEMBER 31, 1974

BE IT ORDAINED by the Mayor and Councilmen of the City of Orangeburg, S. C., in Council assembled, and by authority of the same:

That for the purpose of raising supplies and meeting the ordinary expenses of the City of Orangeburg, S.C., for the year commencing January 1, 1974 and ending December 31, 1974, that a tax of sixty (60) mills be and the same is hereby assessed on each dollar of the assessed value of all real estate and personal property within the City of Orangeburg, S.C., except as such which is exempt from taxation by law.

Tax levied under this ordinance shall be due and payable at the office of the City Clerk and Treasurer, in the Municipal Building of the City of Orangeburg, S.C., from the fifteenth (15) day of October, 1974 until the thirtiety (30) day of November, 1974, from the hours of 9:00 A.M. to 5:00 P.M., Monday through Fridays. Saturdays and Sundays excepted.

After November 30, 1974, a penalty of fifteen (15) percent shall be added to all unpaid taxes until December 31, 1974. On January 1, 1975 executions shall be issued on all unpaid taxes by the City Clerk and Treasurer and delivered to the Delinquent Tax Collector, an additional cost of Two Dollars \$2.00) added to the penalties already incurred.

That for the purpose of carrying into effect this ordinance, the City Clerk and Treasurer is hereby authorized, empowered and directed to take such steps and do all things that may be necessary thereto as is provided by law and the ordinances of the City of Orangeburg, S. C.,
