

ORDINANCE NO. 2021-09

AN ORDINANCE TO RAISE REVENUE AND ADOPT A BUDGET FOR THE CITY OF ORANGEBURG, SOUTH CAROLINA FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2021 AND ENDING SEPTEMBER 30, 2022

BE IT ORDAINED by the Mayor and Council Members of the City of Orangeburg, South Carolina, in Council assembled, and by authority of the same:

SECTION 1. In accordance with Sections 5-7-260 (3) and 5-11-40 (c) of the 1976 Code of Laws of South Carolina, Council shall act by Ordinance to adopt budgets, levy taxes, and collect all other income sources available to the City pursuant to public notice.

SECTION 2. That the balanced budget in the amount of \$23,880,036 for the fiscal year October 1, 2021 - September 30, 2022, and the estimated revenues for payment of same is hereby adopted as if fully incorporated herein.

SECTION 3. That a tax for the period beginning on the first day of January, 2021 and ending on the thirty-first day of December, 2021, both inclusive, for the sums and in the manner hereinafter mentioned, is hereby and shall be levied and collected by the Orangeburg County Treasurer and paid into the treasury of the City of Orangeburg for the use and service thereof; i.e., a tax of 100 mills be and the same is hereby assessed on each dollar of the assessed value of all real estate and personal property within the City of Orangeburg, South Carolina, except as such which is exempt from taxation by law.

SECTION 4. The tax levied under this Ordinance shall be due and payable at the office of the Orangeburg County Treasurer, in Orangeburg, South Carolina, from the first day of November 2021, until the fifteenth day of January 2022, from the hours of 8:30 A.M. until 5:00 P.M., Monday through Friday, except for Saturdays and Sundays.

SECTION 5. A bound copy of the budget containing detailed schedules of Revenues and Expenditures and identifying the sources of anticipated revenues, including taxes necessary to meet the financial requirements of the budget, shall be prepared and maintained as an official record in the office of the City Administrator.

SECTION 6. If for any reason, any section, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid by a valid judgment or decree of any Court of competent jurisdiction, such shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance.
